## Pension application of John Brown S2393 Transcribed by Will Graves



[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

State of New Jersey County of Salem: SS

On this 18<sup>th</sup> day of September in the year of our Lord 1832 personally appeared before the Judges of the Inferior Court of Common Pleas of the County of Salem in the said State of New Jersey John Brown a resident of the township of Pittsgrove [Pitts Grove]in the County of Salem and State aforesaid aged about Seventy-six years who being first duly sworn according to law doth on his oath make the following declaration in order to obtain the benefit of the provision made by the act of Congress passed June 7<sup>th</sup> A.D. 1832.

That he enlisted in the Army of the United States in the year A.D. 1777 with Captain McLane of the State of Delaware in the 3<sup>rd</sup> Regiment of the Delaware line – that he went first into the militia and served about two years prior to enlisting – that he was present at and fought in the Battles of Brandywine [September 11, 1777] and Germantown [October 4, 1777]. After enlisting with Captain McLane was marched to Virginia – soon after that period, Captain McLane resigned his commission and raised a troop of Horse – this deponent was then transferred to Captain Cummings Company and deponent further declares that for the most part of his time of service he was in the southern States under Generals Lafayette and Green [Nathanael Greene], was present at the recapture of Charleston [December 1782] and was out with General Sullivan against the Indians – this deponent continued in the Army until it was disbanded; that he received a discharge signed as he believes by General Green but that the same has been lost. He hereby relinquishes every claim whatever to a pension or annuity except the present and declares that his name is not on the Pension Roll of any agency of any State to his knowledge.



State of New Jersey County of Salem: Personally appeared in open Court on this 18<sup>th</sup> day of September A.D. 1832 Jacob Bryant<sup>1</sup> who being duly sworn according to law doth on his oath declare and say that he was acquainted with John Brown the above applicant during the war of the Revolution, that he knows that the said John Brown was a soldier during said war, that he enlisted in the 3<sup>rd</sup> Regiment and served under different officers or 2 or 3 years.
