Harrison County Virginia September ye 20th 1813

This Day came Valentine Klepper [sic: Valentine Clapper, pension application S39325] before me one of the Justices of the peace of s'd. County & made oath that John Haney served in the revolutionary war as a soldier in the second brigade & second regiment of the Maryland line Commanded by Colonel [John Eager] Howard first in Captain Prices Company afterwards Commanded by Captain Adgelley [probably Edward Edgerley] & that he the said John Haney was wounded in the left leg below his knee in the battle of the Eutaw Springs with a musked Ball

This day came Valentine Clepper before me a justice of the peace for the county of Harrisson [sic], and made oath that John Haney served in the revolutionary war as a soldier in the second brigade of the Maryland line commanded by Major [Henry] Hardman, the second regiment commanded by Colonel John Steward [sic: John Stewart] & in Captain Benjamin Prices company & that the s'd. John Haney received a wound below his left knee by a musket ball at the Battle of the Eutaw Springs. Given under my hand in the County of Harrisson State of Virginia this 21st day of June in the year 1816.

We whose names are hereunto subscribed being practioners of Physic & surgery do hereby certify that we have this day carefully examined John Hany & do find that his left leg appears to have been broken by a musket ball & his knee dislocated whereby he is rendered incapable of procuring a living by labor Given under our hands at Winchester Octob'r the 15th 1816 [signed] C. Baldwin PS. Utterly disabled [signed] Rob't Baldwin

State and District of Virginia Frederick County Sct

On this first day of July 1818, before me the subscriber, one of the Judges of the General court of the said state and sole and presiding Judge of the Superior Court of law for the said County of Frederick personally appears John Haney aged Seventy five years, resident in the said County in the said state and district, who being by me first duly sworn according to law, doth, on his oath, make the following declaration, in order to obtain the provision made by the late act of Congress, entitled "An act to proved for certain persons engaged in the land and naval service of the United States in the revolutionary war:" That he, the said John Haney enlisted in Fredericktown [Frederick] in the state of Maryland in the fall of the year 1777 in the company commanded by Captain Benjamin Price [BLWt341-300] of the second Maryland regiment on Continental establishment then commanded by Col Thomas Price for three years, and afterwards for the war; that he continued to serve in the said corps, or in the service of the United States until the peace, when he was discharged from service in Annapolis in the said State, that he was in the battles of Monmouth in the state of New Jersey [28 Jun 1778] of Camden [SC, 16 Aug 1780] at Guilford Courthouse [NC, 15 Mar 1781], and Eutaw Springs [SC, 8 Sep 1781], at which place he had his leg broke and was entirely disabled from service, on account of which wound, he has been pension list of the United, at the rate of four Dollars per month, which pension, he doth hereby, in consideration of receiving the benefit of the above [undeciphered word] doth hereby relinquish and release and that he is in reduced circumstances, and stands in need of the assistance of his country for support; and that he has no other evidence now in his power of his said services. except the Documents upon which his said pension was obtained, which supposes are lodged in the [undeciphered word] office

I hereby Certify that it appears from the muster Rolls remaining in the Auditors office that John Heaney enlisted as a private in the second Maryland Regiment on the 3rd of ap'l. 1778 and was discharged on the 1 Nov'r. 1780

At a Court Continued and held for Frederick County the 3^d day of August 1820 On this 3^d day of August 1820 personally appeared in open Court being a court of Record for said County John Haney age upwards of seventy years a resident in said County, who being first duly sworn according to law, doth on his oath declare, that he served in the Revolutionary War, in the company commanded by Capt Benjamin Price in the 2^d Regiment commanded by Colo. Price and others afterwards, and that he hath received a certificate for a pension No 12042. and I do solemnly swear that I was a resident citizen of the United States on the 18th day of March 1818. and that I have not since that time by gift, sale, or in any manner disposed of my property or any part thereof, with intent so to diminish it, as to bring myself within the provisions of an act of Congress entitled, "An Act to provide for certain persons engaged in the land and naval service of the United States in the Revolutionary war" passed on the 18th day of March 1818. and that I have not, nor has any person in trust for me, any property or securities, contracts or debts due to me, nor have I any income of any kind whatsoever, excepting my pension.

I am by trade a Cooper, but am unable to do any work, nor have I been able to work for many years. I have no family

NOTE: On 7 July 1818 Catherine Heney certified that to her own knowledge John "Heney" had served five or six years in the Revolutionary War.
