Pension application of Reuben Plunkett S25752 Transcribed by Will Graves f19VA 10/28/12

Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." State of Kentucky Fayette County Sct.

It is hereby certified that Reuben Plunkett formerly a Sergeant of Captain Churchill Jones' Company in the 3rd United States Regiment of Dragoons commanded by Colonel George Baylor & who is on the Pension Roll for the Kentucky Agency as appears by his transfer & who received as he states wounds (viz.) one in the thorax and one in the abdomen in consequence of the wound in the thorax he has an increased and constant pain in the Breast and Back – and has suffered increased disability from the perishing of his left arm – which in the line of his duty & in the said Service on or about the 28th September 1778 [sic September 27, 1778¹] in New Jersey at a place called "Herington" [?]² in Colo. Baylor's surprise by the Enemy, is not only still disabled in consequence of said injury or wounds but in our opinion is entitled to the proportion of two thirds pay being disabled in the Degree of two thirds from obtaining his subsistence by manual labor

On this 13th day of July 1824 before me the subscriber a Justice of the Peace for the said County of Fayette personally appeared Reuben Plunkett who on his oath declares that he is the same person who formerly belonged to the Company commanded by Captain Churchill Jones in the Regiment commanded by Colonel George Baylor in the 3rd Regiment of light Dragoons in the service of the United States, or the Virginia Continental line, that his name was placed on the Pension roll of the State of Virginia & transferred to Kentucky but has never received a formal certificate and now wishes to obtain one.
