Pension application of John Hall S2590 Transcribed by Will Graves f21SC 12/26/10: rev'd 2/4/22

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

State of Ohio Butler County: Court of Common Pleas of July term A.D. 1832} SS

On this thirtieth day of July in the year of our Lord 1832 personally appeared before the Honorable the Judges of the Court of common pleas in and for the County of Butler in the State of Ohio John Hall a resident of the County of Butler aforesaid aged seventy four years who being first duly sworn according to law doth on his oath make the following declaration in order to obtain the benefit of the act of Congress passed July 7th 1832; that about the beginning of June in the year 1776 he volunteered in Captain George's [perhaps Thomas George of the Camden District Regiment | Company at Hammond's old store on Bush River in South Carolina to serve against the Cherokee Indians who were at that time committing depredations on the frontiers of that State – deponent was marched from Hammond's store to Lindley's Fort [Lyndley's Fort, July 15, 1776] where the company had an engagement with three hundred Cherokees and sixty Tories, after remaining at Lindley support about two weeks deponent was stationed at Fort Ellison under the command of Lieutenant Morgan the Regiment to which the company belonged was commanded by Colonel Jonas Baird [Jonas Beard] deponent remained at Fort Ellison three weeks when he returned home – about the close of the year 1776 deponent was drafted to serve for one month in Captain Waddleton's [William Wadlington's] Company against the Indians near the old boundary line between the Indians and whites on the waters of the Saluda [River] at the expiration of the month deponent was discharged. In the spring of 1777 deponent took his father's wagon and two horses which had been pressed for the service under the command of General Andrew Williamson and hauled flour for the Army, he received a load at Dutch fork between Broad River and Saluda, he drove his wagon first to Augusta in Georgia, thence through Midway Settlement to Altamaha [River] thence to Santillas [Satilla River] thence to St. Mary's River where deponent received a written discharged signed by the Wagon Master General whose name was Calhoun for 100 days service.² He has not this discharge in his possession it being lost or was given up when he drew his pay. About the first of October 1780 deponent volunteered in Captain Lindsey's [John Lindsey's] company, three days after he volunteered he was in the battle on Tyger River in South Carolina where General Sumter was wounded.³ He

knew Colonels Baird, Lyle, Wade Hampton and William Washington. After the battle on Tyger River deponent went into North Carolina he was then sent by General Sumter to any carry an express to Colonel Marshall [Col. John Marshel?] who was lying in the Waxhaw Country. After General Sumter recovered from his wound deponent marched under him to Fort Granby where he continued until the advance of the British from Camden caused Sumter to retreat⁴ – at Jack's Creek he was in an engagement with the British,⁵ they were repulsed the Americans who were commanded chiefly by Sumter and Colonel Hampton – deponent continued in the service in South Carolina until the close of the summer 1782 – he served his for last months under Captain Williams [probably Jeremiah Williams] – Captain Lindsey having been appointed Colonel. Deponent received no written discharge when he left the service – at the time Lord Cornwallis crossed the Catawba [River] on his way to York where he surrendered deponent was with the North Carolina troops at Tucky Seige [sic, Tuckaseegee Ford] deponent has a written record of his age taken from the original record kept by his father, he was born in Ireland September 1758 - he has lived in Butler County Ohio 26 years. He can prove his reputation as a Soldier by William Caldwell who knew deponent during the war and by David Madill a clergyman & James Brown who can testify that deponent sustained a good character for truth and veracity that he is reputed and believed in his neighborhood to have been a Soldier of the revolution. He hereby relinquishes every claim whatever to a pension or annuity except the present and declares that his name is not on the pension roll of the agency of any state.

I William Caldwell⁶ a resident of the County of Butler in the state of Ohio do hereby certify that I was well acquainted with John Hall who has sworn to and subscribed the above declaration before and during the war of the revolution that with him I served part of my time – that I have been well acquainted with him since the revolution and knows that he is reputed and believed in the neighborhood where he resides to have been a soldier of the revolution.
