Pension application of Henry Halsey S2597 f13NC Transcribed by Will Graves 4/2/11 rev'd 12/23/14 : 2/7/22

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

State of North Carolina Chowan County: Court of Pleas & Quarter Sessions September Term 1832

On this 18th day of September personally appeared in open Court, before the Justices of the Court of Pleas & Quarter Sessions of the County of Chowan now sitting Henry Halsey a resident of the County & State aforesaid aged seventy-five years, who being first duly sworn according to law, doth on his oath make the following declaration, in order to obtain the benefit of the Act of Congress, passed June 7th 1832.

That he entered the service of the United States & served as herein stated viz. That he was drafted in the year '77 or '78 by Captain Thomas Hunter and proceeded on his march from the County of Chowan to the village of Kingston [Kinston] in this State where our Captain James Roberts took charge of the Company & John Walton of Chowan was its 1st Lieutenant – that under the command of these officers he joined the Southern division of the Army at headquarters in Augusta (Georgia) the North Carolina militia being commanded by General Ashe [John Ashe] that he was attached to the first Regiment of the North Carolina militia under the command of Colonel Solomon Perkins Camden County North Carolina – that a short time after he joined the main Army General Ashe in a line of march to join General Rutherford [Griffith Rutherford] was attacked by the enemy at Brier Creek Georgia [March 3, 1779] where we were discomfitted and had to make our retreat in[to] South Carolina – that the claimant served in this engagement under the officers above named – that it occurred on the day of March in the year – that one Colonel John P Williams [John Pugh Williams] of Bertie (North Carolina) commanded a Regiment under General Ashe and acted bravely in this contest, & narrowly escaped being taken by the enemy – that General Lincoln [Benjamin Lincoln] commanded the Continental troops at the time this claimant served under General Ashe – that in going to Augusta from North Carolina the company to which claimant was attached encamped two days near Charleston - that he was regularly discharged and immediately returned home after an absence in the service of his Country of more than six months.

This claimant further states that about 12 months after his return from the Southern Campaign, he was drafted by Captain Will. Skinner [William Skinner], that he joined at Edenton North Carolina the Company of Captain Richard Hewett of Tyrrell County North Carolina Joseph Whidbee [Joseph Whidby] of Edenton being first Lieutenant, whence he proceeded to the North West River Bridge in Virginia where he was attached to the Regiment of Colonel James

Blount under the command of General Gregory [Isaac Gregory] – he remained at this station for three months until he was regularly discharged – this claimant has no documentary evidence to support the facts above stated.

I hereby relinquish every claim whatever to a pension or annuity except the present and declare that my name is not on the Agency of the Pension Roll of any State.

Questions propounded to the applicant by the Court

1st Where and in what year were you born?

Ans: In the County of Chowan & in the year 1757

2nd Have you any record of your age and if so where is it? Ans: No

3rd Where were you living when called into service: where have you lived since the Revolutionary War and where do you now live?

Ans: In the County of Chowan, where I have resided ever since.

4th How were you called into service; were you drafted; did you volunteer or were you a substitute, and if in substitute, for whom? Ans: Drafted

5th Did you ever receive a discharge from the service, and if so, by whom was it given and what has become of it?

Ans: I did, but it is lost.

6th State the names of persons to whom you are known in your present neighborhood and who can testify as to your character for veracity and their belief in your services as a soldier in the revolution.

Ans: General Richard F Brownrigg, Exum Simpson & Will: Walton, Esquire We William Ford² & Malachi Halsey³ citizens of the County of Chowan do certify and depose that Henry Halsey was drafted and served in company with us as above stated.

State of North Carolina Chowan County

The amended declaration of Henry Halsey as taken before Joseph Manning Esquire one of the Justices of the peace in & for the County of Chowan.

The applicant being sworn on the Holy Gospels of Almighty God deposeth & saith That he was drafted in the month of November 1778 to go to the South as previously stated that he served in the Southern Campaign three months and that from the period of drafting until he reached home embraced a time of five months – that he was regularly discharged, but that he is old & is illiterate and does not recollect the name of the officer. That in the month of November 1780 he was drafted to go to Virginia as before stated, that he there served three months & was discharged by Lieutenant Joseph Whidbee. This affiant further states that not esteeming these discharges of much value they have been either lost or destroyed.
