## Pension application of Thomas Hetherly S2612 Transcribed by Will Graves

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

## State of Ohio Brown County: SS

On this 24<sup>th</sup> day of July A.D. 1832 personally appeared before the court of Common Pleas of the County of Brown and State of Ohio Thomas Hetherly a resident of Eagle Township in the County of Brown and State of Ohio aged seventy-seven years who being first duly sworn according to law doth on his oath make the following declaration in order to obtain the benefit of the provision made by the act of Congress passed June 7<sup>th</sup> 1832 – that he enlisted in the Army of the United States on the 25<sup>th</sup> day of December 1776 at Leesburg, Loudoun County Virginia with Adam Goff for the term of three years and served in the Second Regiment of the Virginia line on Continental establishment which was commanded by Colonel Alexander Spotswood who was promoted and Colonel Feebecker [Christian Febiger] succeeded him his company was commanded by Captain John P Harrison Lieutenant Valentine Harrison & Ensign Thomas Parker – that he was in the battles of Brandywine [September 11, 1777], Germantown [October 7, 1777] and Monmouth [June 28, 1778], he marched through the States of Virginia, Pennsylvania, Maryland, New Jersey, New York and through most of the New England states and was finally discharged at Little York in the State of Pennsylvania in the year 1780 having served out the full term of his enlistment and some short time more – he received a regular discharge which he filed in the Virginia land office in order to obtain his bounty land.

He hereby relinquishes every claim whatever to a pension or annuity except the present and he declares that his name is not on the roll of any agency in any state.

Sworn to and subscribed the day and year aforesaid in open court.

[Note: This file contains no indication that the Commissioner of Pensions required the standard supporting affidavit of a clergyman and another neighbor as to the reputation of the veteran as a revolutionary war soldier; nor does the file contain any indication that the 7 required interrogatories were put to this veteran.]

[Veteran was pensioned at the rate of \$80 per annum commencing March 4<sup>th</sup>, 1831, for service as a Private for 2 years in the Virginia Continental line.]
