Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." State of Tennessee Sumner County: August Term 1832

On the 15th day of August personally appeared before the Court of Pleas & Ouarter Sessions of Sumner County being a court of record before Thomas Anderson, William Edwards & John L Lawrence Esquires, Richard Johnson a resident of said County & State aged 72 years who being first duly sworn according to law doth on his oath make the following declaration in order to obtain the benefit of the provision made by the Act of Congress passed June 7th 1832. Applicant citizen of the State of Virginia and entered into the militia service of that state from Hanover County in the month of May 1777 for seven weeks in the Regiment commanded by Colonel William Dandridge Major Thomas Johnson & in Captain Robert Dabney's company and marched from Hanover to old Williamsburg and was there discharged at the end of said seven weeks. Applicant in the year 1778 in the month of July again entered into the Militia Service in the State of Virginia from Hanover County & served three months in the Regiment commanded by Colonel Fleming Major Robert Dandridge & in Captain John Anderson's company that he marched from Hanover County through the City of Richmond, James City [County] & Charles City [County] & was stationed at Cabin Point in Surry County Virginia and there discharged after the expiration of said three months he was then pressed by Captain James Waller in the month of July 1779 one of the commissaries of the Army of the United States and served three months at the end of which he was discharged at the Meadow bridge in the State of Virginia applicant again entered into the militia service from Hanover County Virginia in the year 1781 & served one month in the Regiment commanded by Colonel Charles Dabney and in Captain Fox's Company he was commanded in these several Tours of militia brigades by General Nelson [Thomas Nelson]. He then enlisted in the month of January 1781 in the Continental line of the United States from Hanover County Virginia, Served twelve months in the Regiment commanded by Colonel Harvey & in Captain Martin Hawkins company as an artificer in the shoemaking business & marched from Hanover County Virginia to the old Barracks in Albemarle County Virginia then to the City of Richmond there duly discharged at the end of said twelve months by Captain Martin Hawkins. He hereby relinquishes every claim whatever to a pension or annuity except the present and he declares his name is not on the pension roll of any agency in any state.
