
[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." State of Tennessee, Sullivan County: August Sessions 1832

On this 21<sup>st</sup> day of August 1832 personally appeared in open Court before the Justices of the Court of Pleas & quarter Sessions for said County now sitting John King a resident citizen of the County and State aforesaid aged seventy-four years who being first duly sworn according to law doth on his oath make the following declaration in order to obtain the benefits of the provision made by the act of Congress passed June 7<sup>th</sup> 1832. That he entered the service of the United States in the following named officers & served as herein stated, to wit: that in December 1778 in Lancaster County Pennsylvania he volunteered for a six weeks tour under Captain Robert Elder of Genl. Potts division of Pennsylvania militia and marched to repel the British in New Jersey and had on their way met the Hessians which had been taken at Trenton and continued his service in that quarter till discharged, by said Captain Elder at Middlesex New Jersey which discharge is herewith exhibited. That in October 1779 he was called out for a two months tour under Captain Whitley of the Pennsylvania militia, of Col. Boyd's command, and marched to White Marsh where Genl. Washington was stationed with his command, and remained in that vicinity until he was discharged, which discharge was given him by Lieutenant Levan [?] his Captain Whitley having been killed at Chestnut Hill [perhaps a reference to the Battle of Chestnut Neck, October 6, 1778] which was the only conspicuous battle he was in that tour which discharge he also produces annexed. That he in the August of the next year volunteered under Captain Moore to go with General Wayne [Anthony Wayne] against the Shawnee Indians who had driven the inhabitants from the Susquehanna River and marched under said Wayne to a town called Charming [?] and continued in service for three months under the command aforesaid against the British & Shawnee but was not favored with a written discharge, but was verbally discharged when his term expired. That in the year 1779, he again volunteered to go under Captain Snider to go to Philadelphia to repel the British from that City and was out about two months, but the British having retreated therefrom there was no active service performed during that time nor had he any discharge for this service that time except by parole that he was frequently (owing to his being so near the seat of war) called out for short periods of some times days & again weeks that he cannot now enumerate them at this service [?] but was near two years off and on in the service before the year 1780 at which time he removed to the territory now Tennessee (then North Carolina) and in the fall of 1780 he volunteered to go against the Cherokee Indians marched to Chota at repel them and took some prisoners, that service was performed under Captain Andrew Cowan, and the service was continued about two months, that he has no documentary evidence to produce save the annexed nor is there any person whose testimony he can obtain by whom he can establish his said services except that annexed. He hereby relinquishes every claim whatever to a pension or an annuity except the present & he declares that his name is not on the pension roll of any Agency in any State.







"This is to Certify that Jno. King Entred in my Compy third December for the term of six Weeks & is now Discharged By me.




