Pension application of Hardy Matthews S2746 Transcribed by Will Graves 4/17/09: rev'd 7/13/16

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

[p 3] State of North Carolina Cumberland County: Court of Pleas & Quarter Sessions September

On this 4th day of September 1832 personally appeared in open Court Hardy Matthews a resident of said County and State aged about seventy-three years who being duly sworn according to law doth on his oath make the following declaration in order to obtain the benefit of the act of Congress passed June 7th 1832. That he entered the service of the United States sometime in the year 1779 being drafted in a Company of Militia commanded by Capt. Nathan King [Nathaniel King] of Cumberland County our Company was attached to Col. Johnston's [Jonas Johnston's] Regiment to which Major Richardson was attached we marched from Cumberland County out to South Carolina where we joined the Continental troops under General Lincoln [Benjamin Lincoln] was engaged in pursuit of the British Army until we came up with them at Stono¹ where a Battle was fought between our troops & the British [I] was not in the battle being out on fatigue at the time immediately after the Battle my term of service expired I received a discharge from Capt. King served this tour for months. I again entered the service as a volunteer in a light horse company commanded by Capt. Hadley [Joshua Hadley] the terms on which the Light Horse was raised was if a man found his own horse & served two months it was to be considered as equal to three months service of a foot man. I found my own horse & served the two months out & was regularly discharged after this I again volunteered under Capt. Hadley for three months but finding my own horse I was only required to serve as before two months during these two terms of service we were engaged scouring the Country around Cross Creek in breaking up the Tories. After the expiration of the first tour I received a discharge from Capt. Hadley but before my second tour expired Capt. Hadley was killed by the Tories -- during this two last mentioned terms of service we never left the State. I again entered the service for three months in Capt. Robert High's Company of Militia as a substitute in the room of one Frederick Holden during this service I was marched towards the Town of Wilmington & was stationed near the Big bridge near Wilmington after remaining there something upwards of a month news reached us of the surrender of Lord Cornwallis [Yorktown, October 19, 1781] when our troops were disbanded & we returned home. I also served another tour in the light horse under Capt. Hadley previous to my entering the service under Capt. High this was two months service but in consideration of my finding my own horse it was to be taken as three months service as before

explained during the three tours of service in the Light horse under Capt. Hadley we were attached to the command of Col. Thomas Armstrong late of this County.

The following answers were then made to the interrogatories prescribed by the War Department

I was born in the County of Nash North Carolina 7th day of April 1759.

I have no record of my age it being burnt in my house many years ago.

I was living in the County of Cumberland, when I entered the service & with the exception of nearly two years I have lived there ever since & still reside there.

The first tour I was drafted, the three next I was a volunteer under Capt. Hadley & the last I was a substitute in Capt. High's company.

I received two discharges from Capt. Hadley but owing to his death I did not receive the 3rd, I received one from Capt. King & one from Capt. Robert High. I have lost all my discharges on their being destroyed in my house by fire.

In addition to those already named I recollect the names of General Williamson & Butler [John Butler] also a Major Lowry during my tour under Capt. King -- during my service under Capt. High I was under General Rutherford [Griffith Rutherford], Col. Mebane [Robert Mebane] & Major White.

I would refer to Richard Huckabee & Alex McLeod Esquires, I could refer to others if necessary.

He hereby relinquishes every claim whatsoever to a Pension or annuity except the present and declares that his name is not on the pension roll of any Agency of any State.
