Pension application of John McAdams (McCaddames) S2762 Transcribed by Will Graves

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

[p 4] State of Tennessee, Sumner County

On this 11th day of March 1833 personally appeared in open Court, before the Judge of the Circuit Court of Sumner now sitting John McAdams, a resident of said County and State, and aged about seventy three years, who being first duly sworn according to law, doth on his oath make the following declaration in order to obtain the benefit of the Act of Congress, passed June 7th, 1832.

In the month of June 1780 applicant then residing in Orange County North Carolina, substituted in the place of his father, who had been drafted for a three months Tour, he was commanded by Captain George Horton, Major Justice & Colonel Lytle, Applicant does not recollect the number of the Regiment, the Brigade to which applicant belonged was commanded by General John Butler. Applicant marched to South Carolina and was in the Battle near Camden [Battle of Camden, August 15-16, 1780], where General Gates [Horatio Gates] was defeated by Cornwallis which took place in August 1780. Of the American officers who commanded at this battle applicant recollects Generals Gist [Mordecai Gist], Stevens [Edward Stevens], Caswell [Richard Caswell] & Gates, Smallwood [William Smallwood] & Baron DeKalb, who fell, Colonels Armand [Lt. Col. Charles Tuffin Armand], Williams [Otho Holland Williams: a short time after this battle he made good his retreat [?] home. Applicant together with his Company was assembled at Hillsboro & was regularly discharged by his Captain, his Term of service having expired. In September or October following Applicant volunteered for five months & was commanded by Captain Horton, Major Justice & Colonel Lytle during this time Applicant was principally engaged against the Tories down among the Swamps & on Cross Creek, during this time Applicant was in two little skirmishes with the Tories in which some were killed & some taken prisoners and afterwards executed. At the end of this Tour Applicant was marched back to Hillsborough and regularly discharged by Captain Horton. This is all the services rendered by applicant in the Revolutionary War, both of which Tours he performed as a private. Applicant has lost his discharges. Applicant resided in Orange County until about 1800, when he moved to Tennessee, Sumner County, where he has resided ever since. Applicant has no Documentary evidence of his service. He knows of no person living, whose testimony he can procure by whom he can prove his service.

He hereby relinquishes every claim, whatever to a Pension or annuity except the present, and declares that his name is not on the Pension Roll of the Agency of any State or Territory.
