Pension application of James Bates S2938 Transcribed by Will Graves

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

State of Tennessee, Sullivan County: August Sessions 1832

On this 21st day of August 1832 personally appeared in open Court before the Justices of the Court of Pleas and Quarter Sessions for said County now sitting James Bates – a resident of the County and State aforesaid aged seventy-one years who first being duly sworn according to law doth on his oath make the following declaration in order to obtain the benefit of the act of Congress passed June 7th 1832. That he entered the service of the United States under the following named Officers and served as herein stated, to wit, that in the year 1780 he was drafted in Orange County North Carolina and joined the Army in Orange County in said State under General Lincholen [Benjamin Lincoln], Colonel O'Neal [William O'Neal], Major Guinn & Captain Travsell [probably James Trousdale?] from thence he was marched to Charles town [sic, Charleston] where he remained three months where he was discharged making in all from the time he entered the service about five months, in about two months after he returned home from said tour he was again Drafted in said County and State and was kept in the neighboring Counties to keep down the Tories, he states that he was in one battle on Haw River at Whitesells Mill [Wetzel's Mill, March 6, 1781], at no of the particular battles in several skirmishes, was discharged by Colonel Hinton [perhaps John Hinton] at Santee hills and lost the same at Cheraw.

He hereby relinquishes every claim whatever to a pension or annuity except the present, and declares that his name is not on the pension roll of the agency of any state.

Sworn to and subscribed in open Court this day & year last before written.

State of Tennessee, Sullivan County

On this 4th day of February 1833 Personally appeared before me Samuel Rhea – an acting Justice of the peace in and for the said County James Bates the applicant for pension to whose declaration the objections in the foregoing brief are marked in red ink, and after being first duly sworn by me deposed & stated in amendment & explanation of his said declaration that he in his two several engagements served in the Revolutionary war the term of six months – of which service he is very confident – as a private soldier each time & embracing the whole term. That in answer to No. 13 of the foregoing he states that there is no witness by whom he can now prove his service. And in answer to interrogatories 1, 2, 6, 7 under No. 19, That he was born in the County of Brunswick State of Virginia on the __ day of March 1764 that he has no record evidence of his age in his possession. That he was discharged by Colonel Hinton at Santee Hills South Carolina. That James Hall & William Barnes are persons well known to him of his veracity who have testified as to his veracity, & given evidence of their knowledge of his reputed service in the Revolutionary war. Sworn to & subscribed before me the date first before written.

James Bates further states that he is confident that when he entered the service in December 1780, he understood his father then to tell him that he was 16 years of age and that he is 68 years old last March instead of 71 as stated in his original declaration and believes that Mr. Blair who drew up his original declaration misunderstood him as he made the same statement to him that he has now made, to wit that he was 16 years old when he entered the Service in December 1780-- Sworn and Subscribed the 4th day of February 1833.
