## Pension application of George Holloway 30450 Transcribed by Will Graves

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

State of Kentucky Woodford County to wit
On this 7<sup>th</sup> day of April 1834 personally appeared in open Court by one [of] the justices of the County of Woodford and State of Kentucky now sitting George Holloway aged seventyone years who being first duly sworn according to law doth on his oath make the following declaration in order to obtain the benefit of the act of Congress passed June 7<sup>th</sup> 1832.

That he entered the service in the year 1780 or 1781 as a soldier he was drafted and was attached to Captain George Turner's Company in Caroline County in the State of Virginia & was marched to Richmond & from there to Cabin Point & remained there & was at that time three months in service & was discharged by General Spotswood [Alexander Spotswood] at Petersburg \_\_ McGill [perhaps Charles Magill or McGill] was Commanding as Colonel though I think he was a Major – in the same year he entered the service as a Captain – His Commission was signed by Governor Randolph and he started from Caroline County through Richmond and Petersburg and went on to the South to aid General Gaits [Horatio Gates] but he was Defeated [Battle of Camden, August 15 – 16, 1780] & we met the soldiers & returned to Richmond in Virginia & from thence to Petersburg where he was discharged by General Spotswood. That he then served 3 months as a Captain both of his discharges he has lost as well as his Commission and he does not know any person in Kentucky by whom he can prove his services –

He was Born in Caroline County in the State of Virginia on the 16<sup>th</sup> day of September in 1763 as appears from the Register of his age which he now has in his possession he was living in Caroline County in the State of Virginia when he was called into service he was drafted as soon as he was 18 years old and after serving 3 months & being regularly discharged he was immediately appointed Captain Commissioned & called back into service. The regular officers were General Lafayette, General Spotswood, General Muhlenberg, Colonel McGill. While a soldier he was regularly discharged by General Spotswood & this discharge is lost. When a Captain he was commissioned by Governor Randolph & discharged by General Muhlenberg which commission is also lost, as to persons in his neighborhood to whom he would refer he would name Robert Alexander, Samuel M Wallace, Joseph Quinn, Edward M Blackburn, Colonel John Porter, Willis Field, Henry Clay & RM Johnston. That in the same year he was called out a 2<sup>nd</sup> time as a Captain & marched to Mccus [sic] Mills [Mackey's Mill?] On James River where General Spotswood and Colonel McGill & lay there some time he thinks about 2 months the British then lying a Little below us on the River it was then understood that peace would be made & we were discharged. He lived in Caroline County till 1795 when he moved to Kentucky & has resided in Woodford since 1799 & still resides there. He hereby relinquishes

every claim whatever to a pension or annuity except the present and declares that his name is not on the pension roll of the agency of any state or territory. Sworn to and subscribed the day & year aforesaid

State of Kentucky Fayette County: Sct.

Be it known that before me one of the Commonwealth's Justices of the Peace in and for the County aforesaid, personally appeared Littleton Jeter of said County a credible witness & aged about eighty-one years, and known to me as a revolutionary pensioner – who being duly sworn deposeth and saith

That he was well acquainted with Captain George Holloway now of Woodford County Kentucky having known him intimately in the State of Virginia – That said Holloway held a Captain's Commission in the Virginia militia & that it was generally known and admitted in the County that the said Holloway was a Captain in the Revolutionary War and further saith not.

Sworn and subscribed before me this 10<sup>th</sup> day of November 1835

Be it known that before me one of the Commonwealth's Justices of the Peace in and for the County aforesaid personally appeared Fielding Jeter of said County a credible witness & aged about 75 years, and known to me as a Revolutionary Pensioner – who having been duly sworn, deposeth and saith,

That he is well acquainted with Captain George Holloway, now of Woodford County Kentucky, having known him intimately in the State of Virginia – that said Holloway held a Captain's Commission in the Virginia militia, and as such commanded a company whilst he (Holloway) was engaged in the War of the Revolution – but at what time he entered or left the service he does not now recollect – and further saith not.

[Facts in file: veteran died November 11, 1837 leaving a widow, not named,; the place of his death is not stated; this file contains no other family data.]

[Veteran was pensioned at the rate of \$20 per annum commencing March 4<sup>th</sup>, 1831, for service as a private for 6 months in the Virginia militia.]
