State of Tennessee

Anderson County

On this first date of April 1834 personally appeared before me, Robert Galbraith, one of the acting Justices of the Peace [unintelligible—blotted?] commissioned and sworn to Hold the Court of Pleas and Quarter sessions for said County, William Butler Senior of the County of Anderson, and State of Tennessee, age ninety six years who first being duly sworn according to law doth on his oath make the following declaration in order to obtain the benefits of the provisions of the Act of Congress passed June 7th, 1832.

That he entered the service of the United States under the following named officers and served as

herein stated. He volunteered under Capt. Samuel McCampbell the last of May, 1780 and returned home the last of September, 1780. I served this tour 4 months after the Indians in the Western part of Virginia. We forted at a fort then called McDonalds fort on Greenbrier River where we had a small battle with the Indians there was 66 men in Company we never were attached to any other company during the 4 months I served. We had no officers of a higher grade than a Captain, I received a discharge from my Captain but I have lost said discharge or misplaced it as the same cannot now be found. I entered the service of the United States as a Volunteer under Captain Thomas Helems [sic, Thomas Carson Helm] the last of February 1781 marched into the state of North Carolina. I was at the Battle of Gilford [Sic, Guilford Court House) 15th of March 1781 in which battle my Captain was killed. I returned home the last of May 1781. I never received a discharge for this tour but fought the Battle at Gilford [Sic, Guilford Courthouse] under General Green [Sic, Nathanael Greene] and Morgan [Daniel Morgan] and Col. Charles Wadkin.¹

I resided in the county Bedford, now Campbell County, Virginia at the time I enlisted in the service, volunteered each time, served in all seven months. I have no Revolutionary evidence and I do not know of any person whose testimony I can procure who can testify to my service. I hereby relinquish every claim whatsoever to a pension or an annuity except the present and declare that my name is not on the pension roll of the agency of any state. There is no clergyman residing in my neighborhood is the only reason why I did not procure the certificate of one, Sworn to and subscribed the day and year aforesaid.

And the said Robert Galbraith one of the Justices of the Peace for same County of Anderson State of Tennessee do declare his opinion after the investigation of the matter and putting the interrogatories prescribed by the War Department that this above named applicant was a Revolutionary Soldier and served as he states and the said Justice Galbraith further certify that Richard Oliver and Alexander Galbraith who has signed the preceding certificate are citizens

¹ Note added by Will Graves: I think the veteran confused the names of the officers under whom he served at Guilford Court House. Col. Charles Lynch was the colonel of the Bedford Rifles and is known to have led his regiment at Guilford Court House. One of the captains under Lynch's command was Capt. Thomas Watkins. My guess is that this veteran served under Col. Lynch and Capt. Watkins at Guilford Court House and that, when making his declaration, he confused the two officers' names and said he was under "Col. Charles Wadkin."
