# Pension application of George Hankins (Hawkins) S31102 Transcribed by Will Graves

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

For the purpose of obtaining the benefit of an act for the Relief of Certain Surviving Officers and Soldiers of the Revolution approved on the 15<sup>th</sup> of May 1828, I George Hankins in the County of Shelby and State of Kentucky do hereby declare that I enlisted in the Continental line of the Army of the Revolution and continued in service for two years a Corporal in Captain John Brent's Company in 4<sup>th</sup> Regiment of the Virginia line. I also declare that the pay I received for my service died on my hand [?????]<sup>1</sup>. I also declare that I received a discharge which has long since been lost or mislaid. I further declare that I was never on the Pension list of the United States.

Before me James C Burnett a Justice of the peace in & for the County of Shelby and State of Kentucky, personally appeared this day Joshua Richardson and Peter Rigg Respectable Citizens of the said County who did severally make oath that George Hankins by whom the foregoing declaration was subscribed is generally reputed & believed to have been a Soldier in the Army of the Revolution in manner therein stated. They further state that they have known said George Hankins for upwards of 40 years and that said Hankins has always since they knew him been Reputed and believed to have been a Soldier of the Revolution.

State of Kentucky Shelby County Sct.

On this 17<sup>th</sup> day of September 1832 personally appeared in open Court before the Justices of the Shelby County Court now sitting George Hankins of the County of Shelby and State of Kentucky aged eighty-two years who being first duly sworn doth on his oath make the following declaration in order to obtain the benefit of the act of Congress passed 7<sup>th</sup> June 1832. That he entered the service of the United States under the following named officers and served as herein stated. That he was enlisted in Charlotte County and State of Virginia soon after the commencement of the American Revolution, the year not recollected, for the term of two years, in the company commanded by Captain John Brent or Brunt whose Lieutenant was \_\_\_ Spencer

his first name not recollected, in the 4<sup>th</sup> Virginia Regiment commanded by Colonel Read [Isaac Read]. He marched from Charlotte Courthouse to Norfolk, from Norfolk to Philadelphia, he was in the battles of Brandywine [September 11, 1777], Germantown [October 4, 1777], the Plains [perhaps White Plains, October 28, 1776] and the Long Bridge [December 9, 1775] and many other skirmishes, He served two years the time for which he enlisted and received an Honorable discharge, which discharge he kept for many years, but which he cannot now find it. He the said Hankins has only set forth in the foregoing declaration such facts as he distinctly recollects, the date of his enlistment as above stated, and many other incidents he does not sufficiently recollect to swear to. He the said George Hankins hereby relinquishes every claim whatever to a pension or annuity except the present, and declares that his name is not on the pension roll of the agency of any State or Territory.

#### Shelby County Kentucky Sct [5 Jan 1822]

George Hankins personally appeared before me Ja. C. Burnett a Justice of the peace for said county and made oath that he Inlisted in Virginia in the year 1776 for three years as a Sergeant in Capt John Brunt's [sic: John Brent VAS2630] Company in the fourth Virginia Regiment on Continental line Commanded by Col Robert Lawson [VAS850] and that he continued to serve in said service untill said Inlistment was expired at which time he was honorably discharged at Schoolkill [sic: Schuylkill] in Pennsylvania and that he was appointed a Sergeant when he first Inlisted and continued to act as such all the time of such Inlistment and was discharged a Sergeant and through the course of time he has lost his discharge and has never rec'd his land warrant for said service
