Pension application of Charles Byles (Biles) S3113 fn20NC Transcribed by Will Graves 10/20/10

Declaration in order to obtain the benefit of the act of Congress passed June seventh 1832 State of Tennessee Henry County: September Sessions 1832

On this 4th day of September 1832 personally appeared Charles Byles in open court before the worshipful County Court of said County now sitting being a resident of said County & State aged about eighty-three years who being first duly sworn according to law doth on his oath make the following declaration in order to entitle him to a pension under said act of Congress –

That he entered the service of the United States about the year 1778 – in the month of March in the town of Salisbury – County of Rowan and State of North Carolina – of which County he was a citizen at that period – as a volunteer in the company commanded by Captain Hugh Montgomery – Lieutenants in said company – James Craig & David Nesbitt – which company was attached to Colonel Francis Locke's Regiment – and General Griffith Rutherford's Brigade that he served a three months tour in said company – that during said tour they traveled through Salisbury to Fayetteville and beyond about twenty or thirty miles – after serving said three months tour – he again entered the service on the 10th of March 1779 in Salisbury – and served about five months – in the company commanded by Captain Robert Bartley – Lieutenants William R Davie – who was the late General Davie of North Carolina – distinguished in that State as a lawyer & Nathaniel Alexander which company was for a time attached to Colonel Malmadd Regiment [sic, Malmedy's Regiment], a French officer – afterwards we were attached to a Regiment of the Virginia line – we passed through Charlotte – on or near Augusta in Georgia – from thence to Charlestown – we met the enemy at Stono where we had a severe engagement or battle with them – soon after said battle we returned home –

He hereby relinquishes every claim to a pension except the present and declares that his name is not on the pension roll of the agency of any State – The last tour we were commanded by General Lincoln.

State of Tennessee Henry County: Personally appeared before me Henry Miller an acting Justice

of the peace for said County – Charles Biles – who being duly sworn – deposeth and saith, that by reason of old age and the consequent loss of memory, he cannot swear positively as to the precise length of his service – but according to the best of his recollection he served not less than the periods mentioned below in his deposition and served in the grades already stated. He has no documentary evidence by which he can prove his services. That if he ever got a discharge he has either lost or mislaid the same – not expecting that the same would ever be of use to him – and for which service I claim a pension.

[Veteran was pensioned at the rate of \$26.66 per annum commencing March fourth, 1831, for eight months service as a private in the North Carolina militia.]
