Pension application of George King S31189 Transcribed by Will Graves

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

Kentucky Cumberland County to wit

On this 2nd day of January 1833 personally appeared before me the undersigned a Justice of the peace in and for said County George King a resident Citizen of the County of Cumberland and State of Kentucky, aged eighty-three years who being first duly sworn according to law doth on his oath make the following declaration in order to obtain the benefit of the Act of Congress passed June 7th 1832.

That he entered the service of the United States under the following named officers and served as herein stated –

That he entered the service as a drafted Militia in the year 1781 in the County of Amelia State of Virginia under Captain Falks [probably Gabriel Fowlkes] & Major Tho. Williamsⁱ and continued to serve that tour three months –

That he was drafted a second time from Lunenburg County Virginia in year 1781 and served under Captain Dowson [sic, Dawson?] and commanded by Colonel Cock & continued to serve six months & the militia from Lunenburg were discharged at the Deep River about 30 miles from Hillsboro North Carolina.

That he was drafted a third time from Lunenburg County Virginia in the year of 1781 in the fall of that year and served under Captain Knight & from Lunenburg we marched down to Gloster [Gloucester] below York and was at the taking of Cornwallis in October of the year 1781 [October 19, 1781] – that he served 7 weeks during this tour & was discharged at Gloster immediately after the taking of Cornwallis.

That the full length of his whole service was at least seven months, if not more, for which he claims a pension – that he has no discharges for his several tours if ever he received any, he has lost or mislaid them – and he knows of but one person living in his County who can testify as to his service and that person is Mrs. Fanny McCullock. That he is personally acquainted with Reuben Alexander, Ingram Alexander, Thomas Alexander, Peter Gearhart & many others who live in his neighborhood & who can testify as to his character for veracity & their belief of his services as a soldier of the revolution.

- 1. That he was born in Virginia on the Chesapeake Northumberland County in the year 1750 he has no record of his age having only a traditionary account of it.
- 2. That he was living in Amelia County Virginia when called into service his first tour & in Lunenburg County Virginia his two last tours that he removed from Lunenburg to Henry County Virginia in the year 1798 or 1799 lived in Henry County near twenty years from thence to Cumberland County Kentucky in 1819 where he now lives & has lived ever since he removed

from Henry. That he was in service with General Lawson [Robert Lawson] at the Battle of Guilford [March 15, 1781] and under Lafayette at the taking of Cornwallis – the 6th & 7th interrogatories having been previously answered –

He hereby relinquishes every claim whatever to a pension or annuity except the present & declares that his name is not on the pension roll of the agency of any State. Sworn to & subscribed the day & year aforesaid.

Before me the undersigned a Justice of the peace in & for said County, personally appeared Fanny McCullock a resident of this County who made oath that she of her own knowledge knows that the aforesaid George King did start from home the several tours by him declared and that he returned as he has stated, & verily believes he rendered the service as by him mentioned – that she is 63 years of age. And I further certify that from old age and bodily infirmity the said George King cannot Conveniently attend court, living at least twenty miles from the Courthouse of my County and that John M Alexander & Thomas Alexander, Ingram Alexander & Peter Gearhart came before me and made oath that they are well acquainted with the said George King who has subscribed & sworn to the foregoing declaration; that they believe him to be 83 years old, that he is reputed and believed in the neighborhood where he resides to have been a soldier of the revolution, and that they concur in that opinion. And I further certify that the said George King, Fanny McCullock, Ingram Alexander and Peter Gearhart or persons of credibility and that their statements are entitled to full credit. Given under our hands this 2nd day of January 1833
