## Pension application of James Lock S31220 Transcribed by Will Graves

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

## State of Illinois Wayne County: SS

On this 29 day of August A.D. 1832 personally appeared in open court before the Wayne Circuit Court being a court of record now sitting James Lock a resident of said Wayne County & State aforesaid aged 71 years who being first duly sworn according to law, doth on his oath make the following declaration in order to obtain the benefit of the Act of Congress passed June 7<sup>th</sup> 1832.

That he entered the service of the United States in the militia under the following named officers and served as herein stated. General \_\_ McIntosh [Lachlan McIntosh], Colonel William Bone, Lieutenant Colonel Joseph McIntosh, Major Henry Christian name not recollected, Captain Samuel McCaithin [could be McCalthin, but neither recognized] Lieutenants none recollected about the last of August or first of September 1779 – that he resided in Augusta County Virginia. That he was drafted in the service, engaged in no battles, that he marched from Augusta County to Fort McIntosh then building on the Ohio River about 20 miles as he thinks below Pittsburg in Pennsylvania, remained there about three weeks, then marched to the mouth of Tuscarora Creek which emptied into the Muskingum River in the State of Ohio remained there \_\_ week building a stockade Fort, then marched back to Fort McIntosh his three months having expired & was discharged. That he recollects Colonel Broadhead [Daniel Brodhead] of the regulars who was at Fort McIntosh when he was first there.

That he again entered the service under Colonel William Dark [William Darke] Lieutenant Colonel and Major not recollected, Captain John McCoomick [John McCormick], Lieutenants not recollected in the month of September 1781, that he resided in Berkeley County Virginia was drafted and marched from thence to Yorktown. That Colonel Dark's Regiment was not engaged in any service except building at the entrenchments & that they were stationed on the South East side of the town. That he remained there until after the taking of Cornwallis when his tour of three months expired, that he was then discharged & returned home.

That he has no documentary evidence: that he never received a written discharge, that he was drafted both of the above periods. That he knows of no person whose testimony he can procure that had a personal knowledge of his services.

That he was born in the County of Berkeley State of Virginia on the 26<sup>th</sup> of August A.D. 1761. That he has a copy of the record of his age taken from one in his father's possession.

That he was living when called into service the first time in Augusta County Virginia in Berkeley County Virginia when called into service the 2<sup>nd</sup> time, that he resided there ten years after his last discharge, then removed to Mercer County Kentucky resided there three years then

to Barren County same State resided there three years, Then to Jackson County Tennessee, resided there five years, then back to Barren County Kentucky, resided there three years, then to Smith County Tennessee, resided there three years then back to Barren County Kentucky there three years & then to Wayne County Illinois where he has since resided.

That John Walker & George W Farris are persons residing in my present neighborhood who will testify as to my character for veracity & their belief of my services as a soldier of the revolution.

He hereby relinquishes every claim whatever to a pension or annuity except the present and declares that his name is not on the pension roll of the agency of any State.

[Veteran was pensioned at the rate of \$20 per annum commencing March 4<sup>th</sup>, 1831, for service as a private for 6 months in the Virginia militia.]
