## State of Illinois County of Madison

On this 22nd day of October in the year of our Lord 1832, personally appeared in open Court, before the Circuit Court for the County of Madison and State of Illinois now sitting, Isham Randle, a resident of Goshen Township, in the County of Madison and State of Illinois aged 73 years, who being first duly sworn according to law, doth on his oath, make the following declaration in order to obtain the benefit of the Act of Congress passed June 7th, 1832. That he entered the service of the United States under the following named officers and served as herein stated, that he entered as a private volunteer soldier under the command of Captain Crump he thinks, the year not recollected, in the North Carolina Militia and to the best of his recollection in the County of Montgomery where he then resided, and marched through several of the adjoining Counties in said State, to wit, Anson, Mecklenburg and Roan [sic, Rowan], in pursuit of the Tories, that other Companies were in this Service at the same time, and he thinks all were under the command of Colonel Ledbetter & he also thinks the Major's name was Crump, that they had several small skirmishes with the Tories, and killed several of them, he thinks in the County of Anson & that several of the Whigs were wounded but none killed, he thinks that he was in service at this time between 3 and 4 months, and was discharged just before General Gates was defeated in South Carolina. He states that he received no written discharge for this service. That he has no documentary evidence and that he knows of no person whose testimony he can procure who can testify to this Service. He states that he removed to Virginia in the fall of the same year that he served in North Carolina. And the next fall after his removal to Virginia, he volunteered as a private in the militia in the County of Brunswick where he then resided in said State of Virginia under the command of Captain Edmund Wilkins in the month of October or November to the best of his recollection, and marched from there to Petersburg, the place of Rendezvous where he marched with the rest of the troops into the County of Isle of Wight where they were all under the command of General Lawson, and remained there principally in said County until they were discharged. He states that he was detailed at this time as one of the guard stationed at the Sleepy hole ferry, on the Nansemond River and remained there for about 6 weeks under the command of a Lieutenant, whose name he does not recollect. During this service General Lawson was sent to some other place and General Muhlenberg took the command -- he does not recollect the names of any other officers in this Service. He states that he was discharged near Suffolk in the month of march or April next ensuing his being called into service, and was in service at this time for 5 months: He states that he was in no battle during this Service -- that he received a discharge for the same, but that the same was lost by him in Virginia. That he has no documentary evidence and that he knows of no person whose testimony he can procure, who can

testify to this Service. He states that he was born in Brunswick County in the State of Virginia removed from there to North Carolina about 3 years before he volunteered in North Carolina as before stated, then removed back to Brunswick County in Virginia as before mentioned & remained in said County of Brunswick until the close of the revolutionary war, a few years after the war he removed again to Montgomery County in North Carolina, resided there about 30 years, then moved to Putnam County in the State of Georgia, resided there a little better than 2 years, and removed from there in 1817 to Madison County, then territory, now State of Illinois, where he has resided ever since. He states that he has a record of his age which is now in Adams County in this State.

He hereby relinquishes every claim whatever to a pension or annuity except the present, and declares that his name is not on the roll of the Agency of any State. Sworn to and subscribed the day and year aforesaid – in open Court
