## Pension application of John Allbritton (Albritton) S31517

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

## State of Georgia, Franklin County

On this third day of September in the year 1832 personally appeared before the Inferior Court of the County & State aforesaid, now sitting, for ordinary purposes, John Allbritton, a resident of Captain Vaughan's district in the County & State aforesaid aged about Eighty five years, who being first duly sworn according to law doth on his oath make the following declaration in order to obtain the benefit of the Act of Congress passed June the 7<sup>th</sup> 1832. That he entered the service of the United States under the following named officers and served as herein stated, viz., That he entered the service of the United States in the year 1774 or about that time, as a volunteer in the militia in the State of Virginia as a private in Captain George's Company, but immediately under the command of Lieutenant Francis Underwood, in Colonel Charles Scott's Regiment & marched to Williamsburg in search of Governor Dunmore [John Murray, Lord Dunmore, the last Royal Governor of the Colony of Virginia], & remained in service four weeks. From thence he removed to Union District in the State of South Carolina, where [he] volunteered in Captain Joshua Palmer's Company & served afterwards in Captain Hughes's Company & served at different times in Colonel Brannon's [sic, Thomas Brandon's] Regiment for three years or more, & was at the Battle of the Cowpens [January 17, 1781], where General Morgan [Daniel Morgan] commanded – during the above three years service he was marched to Augusta in the State of Georgia, & also Bacon's Bridge, soon after the Battle at the Cowpens he was taken Prisoner by the British and retained by them six months or more, soon after he was released from them peace was made, he never received any discharge.

To the Interrogatories of the Court he answers as follows, to wit:

- 1. He was born in Newcastle Hanover County in the State of Virginia, December of the 6<sup>th</sup> 1747
- 2. He has a record of his age, which is here to the Court shown
- 3. He lived in Goochland County in the State of Virginia, from thence he moved to the State of South Carolina, & remained there till the war closed, & from there he removed to the County of Elbert in the State of Georgia, from thence to Franklin County in the said State of Georgia, where he has resided ever since
- 4. He volunteered
- 5. General Morgan was at the Battle of the Cowpens, does not recollect any other officers except those mentioned in the above declaration
- 6. He never received any discharge that he recollects
- 7. He is known to William Glover & Dozier Thornton a preacher of the Gospel who can testify to his veracity &c.

He hereby relinquishes every claim whatever to a pension or annuity except the present, & declares that his name is not on the pension roll of the agency of any State.

State of Georgia, County of Franklin

Personally appeared before the Inferior Court now sitting for ordinary purposes John Albritton [sic] who being sworn according to law on oath makes the following addition an amendment to his declaration hereto annexed, viz.: That he served in 1774 one month under Captain George in the Regiment commanded by Charles Scott in Virginia.

In 1779 he entered Captain Pelmore [sic, Palmer's] Company in Union District South Carolina in Colonel Thomas Brannon's [sic, Thomas Brandon's] Regiment, & was marched to Augusta & remained opposite to Augusta on the Carolina side of the river upwards of two months & was then marched to Bacon's Bridge about 20 miles above Charleston and was stationed there about one month from thence was marched back to Union District and was marched to Rowan County North Carolina near Charlotte C. H. & remained there six weeks & returned home, & served in the last Tour eight months.

In January 1781 he again entered the service at Union aforesaid under Captain Palmer in Col. Brandon's Regiment & was marched to the Cowpens & was put under the command of General Morgan and was in the battle of the Cowpens & was sent to guard prisoners after the battle to a place called Gilbert or Guilford in North Carolina & after delivering the prisoners, he was taken a prisoner by the Tories under Captain Lee, and was detained until August 1781, and made his escape from them at Dorchester South Carolina & returned home after being out eight months. Declarant further saith that by reason of old age and the consequent loss of memory he cannot state precisely the dates & times he served, but is certain he served three years as a private soldier, in Corps ordered out regularly & by Competent authority, and no part of that time in a civil capacity, & was in the field or in Garrison the whole time above stated.

Declarant knows of no person now in life by whom he could prove that he served, and has no documentary evidence of his service, but has attached to his original Declaration certificates of the general belief in his neighborhood.

Personally appeared before me Jesse Palmer an Acting Justice of the Peace for said District Joshua Pelmore [sic] who being sworn according to law on his oath saith that he is well acquainted with John Allbritton of Franklin County Georgia who applies herewith for a pension. That he believes him to be about Eighty-five years of Age, and to have served as he states. That Deponent was a Captain in the State of South Carolina Militia in the Revolutionary War and that said Allbritton was in actual service in Deponent's Company at different times for Several months according to the best of Deponent's recollection.
