Pension application of Nathaniel Cannon S31594 Transcribed by Will Graves

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

Georgia, Wilkinson County

On this __ day of November 1832 personally appeared in open court before the Inferior Court of said County now sitting Nathaniel Cannon a resident of Wilkinson County and State of Georgia aged between sixty seven and seventy years old from the best information as he has now [sic, no] register of his age who being first duly sworn according to law doth on his oath make the following declaration in order to obtain the benefit of the act of Congress passed June 7th 1832.

That he entered the service of the United States under the following named officers and served as herein stated: that he entered the service by enlisting six months under Capt. Smith [perhaps Garret Smith], Lieutenant Lindsey [perhaps John Lindsay/Lindsey or Thomas Lindsay/Lindsey] commanded by Colonel Williams [James Williams] in General Williamson's [Andrew Williamson's] brigade. [We] marched from Ninety Six District South Carolina to the Cherokee Line between Saludy [sic, Saluda] River & Savannah River and there built a blockhouse. Served my time out and got a discharge but has lost or mislaid it so that I do not know what has become of it but does not know what year but March as he believes. In the month of February, substituted for one month under Capt. Reed, Colonel Williams & Lieutenant Col McCrary [Robert McCreary] but served four months and four days. [We] marched opposite of Augusta South Carolina there joined General Lincoln [spelled "Linkhorn", Benjamin Lincoln]. [We] pursued the British from Augusta [to] Stonon [sic, Stono] Fort on Ashley River there had a battle [June 20, 1779] but cannot recollect the day or year but believes the battle was in the month of August.

[H]e hereby relinquishes every claim whatever to a pension or annuity except the present and declares that his name is not on the pension roll of the agency of any State Sworn to and subscribed to the day and year aforesaid. And in answers to certain interrogations prescribed by the War Department the said applicant further states: That he was born as near as he can recollect in the year 1763 in the State of South Carolina. That he has no record of his age that he resided in the said State until he removed to the State of Georgia, in which last named State he lives at the present time. That he enlisted when he first entered the service. He states the names of Lieut. Lindsey, Capt. Smith, Col. Williams & Lt. Col McCrary as some of his officers; That he received a discharge which has been lost of a number of years. He states the names of Williams Payne & John Hatcher to whom he is known in his present neighborhood who can testify as to his character for veracity and their belief of his serving as a soldier of the Revolution.

We Williams Payne, a clergyman residing in the County of Laurens & State of Georgia, and James Griffin a resident in the County of Wilkinson & said State, hereby certify that we are well acquainted with Nathaniel Cannon who has subscribed & sworn to the above declaration, that we believe him to be nearly seventy years of age, that he is reputed and believed in the neighborhood where he lives to have been a soldier of the Revolution, and that we concur in that opinion. Sworn to & subscribed the day and year aforesaid.

[Veteran was pensioned at the rate of \$33.77 commencing March 4th, 1831, for 10 months & 4 days service as a private in the South Carolina militia.]
