## Pension application of John Goldsmith S31699 Transcribed by Will Graves

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

## State of Georgia, Coweta County

On this the 18th day of September 1832 personally appeared in open court before us John D. Hinton, Samuel D. Echols and Levi T. Wellborn now sitting John Goldsmith a resident of the County and State aforesaid aged 71 Years, who being first duly sworn according to Law, doth on his oath, make the following declaration, in order to obtain the benefit of the act of Congress passed June the 7th 1832. That I entered the service of the United States, under the following named officers, and served as herein stated. That I entered the service in July 1779 and left it in September 1780. I was living in Camberlin [sic, Camden] now Kershaw District South Carolina. I entered as a volunteer for fourteen months in Captain Thomas Baker's company the Regiment was commanded by Colonel Cooper, while in this Regiment, I was in two battles against the Tories, one at Mobley's Meeting House [Battle of Mobley's Meetinghouse, May 1780] on Little River in Camden now Kershaw district SC<sup>2</sup> and the other at Walker's plantation in the same district. I served three months in Captain Baker's company, and was transferred to Captain Willoughby Barton's Company, in the Regiment commanded by Colonel McCoy, in this company & Regiment I served Eleven months and was in a Battle against the Tories at Wallahorn's Ferry [?], about three miles below Augusta Georgia. I served with no regular or Continental troops. I have seen Generals Morgan [Daniel Morgan] & Marion [Francis Marion], but did not serve with either. I have no documentary evidence, and I know of no person, whose testimony I can procure who can testify to my service. I hereby relinquish every claim whatever to a pension or annuity except the present, and declares that his name is not on the pension roll of the agency of any State.

Ans. to the 5<sup>th</sup> Int. I have seen General Morgan & Marion but did not serve with either. I did not at any time served with Continental or regular troops, and the general circumstances of my Service, as such have been before related

Ans. to the 6<sup>th</sup> Int. I never received a discharge

Ans. to the 7<sup>th</sup> Int. I will refer to John Houston & James Lee
