Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

State of Georgia Tattnall County SS

On this Sixth day of May 1833 personally appeared in open Court before their Honors the justices of the Inferior Court for said County now sitting Henry Holland a resident of the State and County aforesaid aged Seventy Eight years who being first duly sworn according to law doth on his oath make the following declaration in order to obtain the benefit of the act of Congress passed June 7th 1832.

That he entered the Service of the United States under the following named officers and served as herein stated.

He entered the service as a volunteer but what date does not exactly recollect under General Livingston [sic, John Alexander Lillington?], Colonel Kenan [James Kenan], Major Ivy, Captain Tool in this expedition he was in service nine months and was in the Battle at Stono [June 20, 1779].¹

Soon after this deponent's return home he was again called into service as a militia man, in this expedition he was in service three years General Green [Nathanael Greene], the name of the Colonel Murphy [Archibald Murphy], Major Ivy, Captain Coleman [Thomas Coleman] and Lieutenant Holmes, during this time was in the Battle at the Eutaw Springs [September 8, 1781].

State of Georgia Tattnall County } On this 17th day of April 1834 personally appeared in open Court before the Justices of the Inferior Court of the County and State aforesaid now sitting Henry Holland, who being duly sworn according to law, doth on his oath make the following amendment to his declaration made on the 6th day of May 1833 in order to obtain the benefit of the provision of the Act of Congress passed 7th of June 1832.

That he entered the service of the United States under the following named officers & served as herein stated.

1stly. That he entered the services of the United States in 1779 in the company commanded by Captain King [Michael King] in Duplin County, North Carolina, that he was under the command of Major Williams & Colonel Kenan – he was marched to Stono and was there stationed for some months previous to the battle at that place in which battle he was engaged, that he received a written discharge from Captain King at Stono, which discharge he has since lost – that in this tour he served six months.

2ndly. That he entered the service of the United States in Duplin County North Carolina in the year 1781 as a militia man for three months under the command of Captain Tool and served under Major Williams, Colonel Brown & General Linnington [sic, John Alexander Lillington] – that he was marched to the Big Bridge near Wilmington – from thence to Elizabeth town where he received a written discharge from Captain Tool, which discharge he has since lost, having served a tour of three months.

3rdly. That he entered the service of the United States in the year 1781 in Duplin County as a volunteer for six months, and was attached to the company commanded by Captain Coleman, and served under Majors Ivy and McRee, Colonel Murphy & General Greene. That during this Campaign he was marched to Wilmington & was there stationed for three months from thence he was marched to Pond-Pond [sic, Edisto River] in South Carolina at which place he joined General Greene's Army and was attached to the 3rd Regiment of said Army that he was in the battle of the Eutaw Springs – that he was marched to Bacon-Bridge [sic, Bacons Bridge] on Ashley River & was there stationed – that from thence he was marched to Ashley Hill and there received a written discharge from Captain Coleman, which said discharge he has also lost – that in this last campaign he served not less than six months.

That he served as a private; that he has no documentary Evidence, and that he knows of no person whose testimony he can procure who can testify to his service, except Peamable Clay a resident of Washington County and State first aforesaid, whose affidavit he hath obtained and will enclose. That he hereby relinquishes every claim whatever to a pension or annuity, except the present, and declares that his name is not on the Roll of the Agency of any State: that he was born in Bantre County [sic, Bertie?] North Carolina on the 1st day of March 1757. That he has a record of his age in an old prayer book in his Father's handwriting. That soon after the close of the Revolutionary War he removed to Warren County Georgia where he lived about four years from thence he removed to Washington County Georgia and lived there about eight years, that he then removed to the County first aforesaid, where he has lived for the last thirty five years.

That the following persons, to wit, John Coward, Jacob Mincy, Joshua Everett, Joseph Tillman, Joseph Collins, Benjamin Brewton, William Tippins, Ezekiel Clifton, Benjamin Alexander and Levi Wright reside in his neighborhood and to whom he is known, and who can testify to his character for veracity and good behavior & their belief of his services as a soldier of the Revolution.

as a Revolutionary Soldier in the old Revolutionary war, from Duplin County North Carolina against the British. Sworn to and subscribed before me December 12th, 1833. S/ Lee Reaves, JP
