Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

State of Illinois, Montgomery County Sct.

County Commissioners Court Special March term 1833

On this 30<sup>th</sup> day of March 1833 personally appeared in open court before the County Commissioners now sitting Benjamin Gordon resident in the County of Montgomery (or Fayette near the line) and the State of Illinois aged Seventy years & three months, who being first duly sworn according to law doth on his oath make the following declaration in order to obtain the benefit of the act of Congress passed June the 7<sup>th</sup> 1832. That he entered the service of the United States under the following named Officers and served as herein stated. He entered the Service in July in the year 1780 in Mecklenburg County near Charlotte and the State of North Carolina under General Thomas Sumpter [sic, Thomas Sumter]. Marched to Hillsboro in North Carolina with the wounded was then sent as Waggoner to General Greene's [Nathanael Greene's] Army then marched under General Clark [sic, Elijah Clarke] of Georgia under the Mountains as a Ranger next marched into Newberry County in South Carolina under Captain Nathaniel Davis Colonel Glen General Levi Casev with whom he continued ranging during the rest of the war and was discharged in Newberry County in the State of South Carolina after serving nearly three years in the year 1783, he was acquainted with Generals Morgan [Daniel Morgan], Greene, Sumter, Clarke & Casey also with Colonels Glen, Williams & Summers. With Captain Virdin, Dugan & Liles, he was in no battle of any consequence. He has no documentary evidence but can prove some of the particulars of his service by James Virdin of Montgomery County Illinois. I hereby relinquish every claim whatever to a pension or an annuity except the present and declare that my name is not on the pension roll of the agency of any State.

Interrogatories propounded by the Court to the said Benjamin Gordon

Quest 1<sup>st</sup> Where and in what year were you born?

Ans: In Newberry County in the State of South Carolina on the 30<sup>th</sup> day of August 1762. Quest 2<sup>nd</sup> Have you any record of your age and if so where is it?

Ans: I have a record of my age at my own house.

Quest 3<sup>rd</sup> Where were you living when called into service: where have you lived since the Revolutionary War and where do you now live?

Ans: I lived in the State of South Carolina when I entered the Service and continued to reside there for 25 or 30 years after the close of the War when I removed to Kentucky in 1812 resided there 10 years & removed to the State of Illinois in 1822 where I have resided for the past 10 years I now live either in the County of Montgomery Lafayette near the line in the State of Illinois Quest 4<sup>th</sup> How were you called into service; were you drafted; did you volunteer or were you a substitute, and if in substitute, for whom?

Ans: I entered the service as a volunteer and so continued

Quest 5<sup>th</sup> State the names of some of the regular officers who were with the troops when you served, such Continental and militia regiments as you can recollect and the general circumstances of your service.

Ans: I do not know the names of any regular officers I think there were none in the Corps in which I served I was acquainted with Lisles Regiment Colonel Glen's Regiment Colonel Williams and Colonel Adam Summers' Regiments all militia or regiments of rangers I belonged entirely to the ranging service.

Quest 6<sup>th</sup> Did you ever receive a discharge from the service, and if so, by whom was it given and what has become of it?

Ans: I never received any except an indent on which I drew pay for my services Quest 7<sup>th</sup> State the names of persons to whom you are known in your present neighborhood and who can testify as to your character for veracity and their belief in your services as a soldier in the revolution.

Ans: I am acquainted with the Reverend Henry Sears & James Virdin. S/Benjamin Gordon<sup>2</sup>

[Henry Sears, a clergyman, and James Virdin gave an affidavit but most of their affidavit is missing from the file and appears to be lost.]

[p 5]State of Illinois, Montgomery County

Be it remembered that on this 10<sup>th</sup> day of August A.D. 1833 the within named Benjamin Gordon, personally appeared before the undersigned an acting Justice of the peace within and for said County and being duly sworn saith that he entered the Service of the United States in Captain Lisles' Company of militia, under General Sumter in July of the year 1780 near Charlotte in Mecklenburg County North Carolina as a private soldier. He served two weeks in that capacity and was then sent by order of General Sumter, with the soldiers horses in search of pasturage, under Major Gordon the father of this Affiant, in which capacity he continued about three weeks; he was then by order of Major Gordon placed as attendant and nurse of the Sick and wounded in Charlotte North Carolina, in which capacity he continued about six weeks, was then sent to Hillsboro, North Carolina with the wounded & Sick. He was then sent by Major Gordon his father as Waggoner in General Greene's Army in which capacity he continued about one month. He then followed the General Greene's Army, under the immediate command of Major Gordon into South Carolina; He was then placed under the Command of General Clarke of Georgia, under whom he continued to range about six weeks under the mountains; But he cannot now remember the name of the Captain under whom he was placed; He was then placed under Captain Nathaniel Davis in Colonel Glen's Regiment under the command of Brigadier General Levi Casey under whom he continued to Served as a private during the remainder of the War. This last service was militia or ranging service, And he was discharged as within stated about three months after the peace was concluded – being in pursuit after the peace of the murderers and Out-lyers. He States explicitly from the time he entered the Service in July 1780 till he was finally discharged in (as he now thinks) August 1782 – making in the whole of his service two years and one month. He was never out of the Service of the United States for one single day. He served the whole time as a private. Sworn to and subscribed before me this day and year above written.
