Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

State of Indiana Floyd County SS

On this 6th day of January personally appeared before the Board of Commissioners of the County of Floyd and State of Indiana, now sitting Andrew Ingram a resident of Greenville Township in the County of Floyd and State of Indiana aged seventy-five years who being first duly sworn according to law doth on his oath make the following declaration in order to obtain the benefit of the provisions made by the Act of Congress passed June 7th 1832. That he entered the service of the United States in the year 1779 in the month of September as near as he can recollect at Montgomery County State of Virginia (his then place of residence), he volunteered under Captain Charles Morgan in a Regiment commanded by Colonel Arthur Campbell and was marched to Long Island of Holston River, where the Regiment was stationed and continued in this service three months and a half & was then discharged. He then returned to Montgomery County and again volunteered in a company of light Horse commanded by Captain William Love in the Regiment of Colonel Arthur Campbell and marched to the head of New River and continued in this company two months and a half and then returned to Montgomery County and again volunteered and joined a Company under command of Captain William Brice in the Regiment of Colonel Campbell and was marched over the Iron Mountain to Cripple Creek & was then taken sick and returned home by consent & direction of Captain Brice, was in this company one month. – He states that he was born in Granville County State of North Carolina in the year 1758. That he has no record of his age. That at the time he was called into service he lived in Montgomery County State of Virginia and that he volunteered. That the names of his captains were first Charles Morgan, 2nd William Love, 3rd William price, his Colonel Arthur Campbell – does not recollect of receiving any written discharges – That he is known to Mordecai Collins, Israel Ramutin [?], & Seth Woodruff [?] in his present neighborhood. That since the revolutionary war he has resided in Holston, Hawkins County, state of Tennessee, until 1819 – at which time he removed to Floyd County Indiana where he has resided ever since & where he now resides. – He has no documentary evidence & knows of no person whose testimony he can procure who can testify to his service. He hereby relinquishes every claim whatever to a pension or annuity except the present and he declares that his name is not on the Pension Roll of the agency of any State.
