## Pension application of Peter Kelly S32352

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

## State of Alabama Wilcox County

On this the 10th day of October 1833 -- personally appeared before me John W. Bridger, Judge of the County Court of said County, Peter Kelly a resident of said County & State at his residence, he being unable to attend Court -- on account of bodily infirmity -- aged eighty-two years, who being first duly Sworn according to law doth on his oath make the following declaration in order to obtain the benefit of the act of Congress passed June the 7th 1832.

That he entered the Service sometime in the month of March in the year 1776, under Colonel Thompson [sic, William Thomson]: Major Mason Captain Parinhuff [sic, Peyerim Hoff or John Lewis Peyer Imhoff] (who died soon after he entered the service) he was then placed under the command of Captain Brown [Richard Brown], that he entered the service for the term of 15 months -- and at the expiration of his time of service he received a discharge from Colonel Thompson on the 15th of June in the year 1777. That at the time when he entered the Service of the United States he resided in Lawrence district [sic, Laurens District] in the State of South Carolina. That soon afterwards he was marched to a place 10 miles from Charleston in the same State, where he was Stationed for several weeks, -- Then he was carried over to Sullivan's Island, and that he was in Fort Moultrie at the time the attack was made by the British fleet [June 28, 1776]. He further states that while on Sullivan's Island he was under the command of General Lee [Charles Lee]. That he was also acquainted with Colonels Moultrie [William Moultrie] & Gadsden [Christopher Gadsden]. That he remained upon Sullivan's Island for several weeks after which he returned to the interior of the State and was Stationed on Congaree River, where he remained for some months under Colonel Thompson during which time he was employed against the Tories, and that the remainder of his time of Service was spent in the middle & lower part of the State, that he was engaged in no other battle after he left Sullivan's Island and at the time he received his discharge, he was at the Utaw Springs [sic, Eutaw Springs] -- The Applicant further states that after he returned home from Eutaw Springs, he remained about months when he was drafted in the Militia under Lieutenant Colonel McCrary [Robert McCrary], & Colonel Williams [James Williams], (who was afterwards killed at the battle of Kings Mountain) -- also under Captain James Dillard & Lieutenant McCrary, and that he was engaged against the Indians, upon the frontier, -- That he was with General Williamson [Andrew Williamson], and under his command in an excursion after the Cherokees, in which they burned several of the

Indian Towns, that in this excursion he was in the Service about six weeks. -- That he was afterwards frequently called into the service, for short periods a part of the time he was under Colonel Pickens [Andrew Pickens] afterwards General Pickens that his latter services were performed entirely in protecting the Country against the depredations of the Tories.

He further States that he has lost his only discharge which he ever received, and that he has no documentary evidence and that he knows of no person whose testimony he can procure who can testify to his services. He hereby relinquishes every claim whatever to a pension or annuity except the present and declares that his name is not on the pension roll of the agency of any State.

Interrogatories by the Judge

1<sup>st</sup> Where and in what year were you born?

A: He was born in Ireland, he thinks in the year 1751 -- He landed at Annapolis in Maryland in 1766 -- & he thinks he was 15 years of age he was at that time and when he left Ireland and a previous to a cabinet Mechanic.

2<sup>nd</sup> Have you any record of your age and if so where is it?

A: He has no record of his age.

3<sup>rd</sup> Where were you living when called into service: where have you lived since the Revolutionary War and where do you now live?

A: He was living when called into service in Laurens district in South Carolina. Soon after the Revolutionary war, he removed to Wilkes County in the State of Georgia, -- where I lived about 2 years, then he removed to Greene County in Georgia, where he remained about 5 years, and returned to Laurens district in South Carolina, where he resided about 14 years, -- Then he removed to the State of Kentucky -- Livingston County, where he resided about 11 years, then he removed to Wilcox County in the State of Alabama, where he now lives. 4<sup>th</sup> How were you called into service; were you drafted; did you volunteer or were you a substitute, and if in substitute, for whom?

A: When I first entered the service, I was a volunteer and served 15 months, I was afterwards drafted.

5<sup>th</sup> State the names of some of the regular officers who were with the troops when you served, such Continental and militia regiments as you can recollect and the general circumstances of your service.

A: He was acquainted with General Lee, he does not recollect that he knew any other Regular Officers for the General Circumstances of his service he refers to the above declaration, It was his early misfortune to receive no education and was unable to keep any record of the events which occurred in his early life and many of the incidents of that day have measurably faded from his memory.

6<sup>th</sup> Did you ever receive a discharge from the service, and if so, by whom was it given and what has become of it?

A: He received a discharge signed by Colonel Thompson -- he does not now know what has become of it.

7<sup>th</sup> State the names of persons to whom you are known in your present neighborhood and who can testify as to your character for veracity and their belief in your services as a soldier in the revolution.

A: He mentions the names of Solomon Perkins a minister of the Gospel, and said Zacheus Green [?] -- both of whom reside in his immediate neighborhood. Sworn to and subscribed the day and year aforesaid.

State of Alabama Wilcox County: On this 20th day of March A.D. 1834 Personally appeared before me William J. Dexter an acting Justice of the Peace in and for said County Peter Kelly a resident of said County and State he being unable to attend Court on account of bodily infirmity who being first duly sworn according to law on his oath doth make the following amendment and explanation to the preceding declaration (hereto attached) in order to obtain the benefit of the act of June 7th 1832. That he Enlisted in the regular service for the period of fifteen months, and that after the expiration of said service he received a discharge from Colonel Thompson on the 15th day of June A.D. 1777.

He further saith on his oath and explanation to the answer of the fourth Question proposed by the Honorable John W. Bridge [balance of the line is illegible] County, that he first served in the militia for a period of two months under the command of General Richardson, And that he afterwards in the month of March 1776 enlisted under the command of Colonel Thompson, Major Mason, Captain Parinhuff and afterwards under Captain Brown in the regular service for the period as above stated of fifteen months -- and continued in said service from the period of his enlistment, until discharged by Colonel Thompson on the 15th day of June 1777 -- And for the General history of his services, refers to his original declaration.

State of Alabama Wilcox County: Personally appeared before me the undersigned Justice of the peace in and for said County Peter Kelly who being duly sworn deposes and says, that reasonably [sic, by reason] of old age and the consequent loss of memory he cannot swear positively to the precise length and dates of his services, but according to the best of his recollection he served for not less than the periods mentioned below -- For one year and 3 months I served as a regular enlisted private, and for such service I claim a pension. Sworn to & subscribed before me this 20th March 1834
