District of the Commonwealth of Massachusetts

Berkshire Ss. on this 24th day of April in the year of our Lord 1818 before me the subscriber first & Presiding Judge of the Circuit Court of Common Pleas for the Western Circuit in said Commonwealth & including the said County of Berkshire, personally appeard David Jewett of Lanesborough [Lanesboro] in said county of the age of nearly sixty years a Citizen of the United States & now resident of said Lanesborough in the District aforesaid who on oath doth make the Decleration following in order to obtain the provission made by the late act of Congress entitled "An act to provide for certain persons engaged in the land & naval service of the United States in the Revolutionary war." - That he enlisted at Lanesborough aforesaid under Lieut. Frisbie & was placed in the light Infantry company, usually or frequently commanded by Capt [Luke] Hitchcock of said county & sometimes by Capt Mills – that he enlisted about the month of February A.D. 1777 & served to the end of the war in the Army of the United States, when he was honourably discharged, as appears by the discharge now offered of June 9 1783 under the signature of General Washington & which is hereunto annexed. that he was at the capture of General Burgoyn [sic: John Burgoyne at Saratoga NY, 17 Oct 1777] & of Cornwallis [at Yorktown VA, 19 Oct 1781] & many other actions during the war. that he is now in small circumstances, possessing small means of support, & is in bad health & not able to perform any considerable service & stands in need of the support provided by the said law.

## By His Excellency GEORGE WASHINGTON, ESQ General and Commander in Chief of the Forces of the United States of America.

THESE are to CERTIFY that the Bearer hereof David Jewet fifer in the first Massachusetts Regiment, having faithfully served the United States Six years & four months and being inlisted for the War only, is hereby DISCHARGED from the American Army.

For the purpose of obtaining the benefit of "An Act for the relief of certain surviving officers and Soldiers of the Army of the Revolution" approved on the fifteenth of May 1828 I David Jewett of Lanesborough in the County of Berkshire in the state of Massachusetts do hereby declare that I enlisted in the Continental Line of the Army of the Revolution for and during the war and continued in its service until its termination, at which period I was a musician in Captain Miller's company in the first Regiment of the Massachusetts line commanded by Col. Joseph Vose. And I further declare that I was not on the fifteenth day of March 1828 on the Pension List of the United States. And I further state that I have not received a certificate for the reward of Eighty dollars for which I was entitled under a resolve of Congress passed the 15<sup>th</sup> May 1778, that I enlisted in the month of February 1777 but had no knowledge of the existence of said act or that I was entitled to a certificate under it. And I further declare that my discharge was transmitted by me to the War office at Washington in 1818 & that it is now on file in said office.
