Pension application of Gilbart (Gilbert) Karney S33347 Transcribed by Will Graves

The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

Be it remembered that on the 25th day of April A.D. 1818 before me James Prost, one of the Judges of the inferior cohort of Common Pleas in and for the County of Monmouth, personally appeared, Gilbert Kerney [sic], who being duly sworn on the holy evangelists of Almighty God, deposeth and saith that he is now a Citizen of the US Residing in Middletown in the County and State aforesaid & that on or about the first of July 1779 he enlisted in the service of the United States in Colonel Morgan's [presumably Daniel Morgan's] Regiment in the company of Captain Tiptins [?]¹. Deponent thinks it was the 15th Regiment in the Virginia line, he served until the first of December 1781, and then he got his discharge, and when he was returning home he put his knapsack wherein his Discharge was in the company of a horseman by the name of Joseph Mason to carry for him, and that Mason went on with said knapsack and he hath not heard of said Mason since By which means he hath lost his Discharge – Declarant saith that he served as a private soldier from the time enlisted until discharged. This deponent on his oath further saith from his reduced circumstances he needs the assistance of his Country for support.

On this 8th day of May 1818 before me the subscriber one of the Judges of the Inferior court of common pleas in and for the County of Monmouth, personally appeared Gilbert Karney, age sixty-three years nine months & eight days resident in Middletown County of Monmouth State of New Jersey, who being by me first duly sworn, according to law, doth on his oath make the following declaration in order to obtain the provision made by the late act of Congress entitled "An act to provide for certain persons engaged in the land and naval service of the United States in the Revolutionary War;" that he the said Gilbert Karney enlisted in Pitsburgh [Pittsburgh] in the State of Pensilvany [Pennsylvania] in the company commanded by Captain Tiptin in the 15 Regiment in the Virginia [service] 1st July 1779 that he continued to serve in the said Corps, or in the service of the United States, until the 1st day of December 1781 when he was

discharged from service in the State of Kaintucky [Kentucky] near the falls of the Ohio, that he was in the Battles at Monmouth [June 28, 1778], Germantown [October 4, 1777], White Plains [October 28, 1777] & own Long Island.

And that he is in reduced circumstances and stands in need of the assistance of his country for support, and that he has no other evidence now in his power of his said services. Sworn to and declared before me the day and year aforesaid.

On this 25th day of July 1820 personally appeared in open Court being a Court of record and the Inferior Court of Common Pleas in and for the said County of Monmouth Gilbert Karney, aged about 67 years, resident in the said County who being first duly sworn according to law doth on his oath declare that he served in the Revolutionary War as follows in Captain John Timpton's Company in the 15th Virginia Regiment commanded by Colonel Morgan [presumably Daniel Morgan], and that his original declaration is dated the 25th day of April 1818 and that the number of his certificate of Pension is (8.428). And I do solemnly swear that I was a resident Citizen of the United States on the 18th day of March 1818 and that I have not since that time by gift, sale or in any manner whatever disposed of my property or any part thereof with intent thereby so to diminish it as to bring myself within the provision of an act of Congress entitled "an act to provide for certain persons engaged in the land and naval service of the United States in the revolutionary war" passed on the 18th day of March 1818, and that I have not nor has any person in trust for me any property, or securities, contracts or debts due to me nor have I any income other than what is contained in the schedule hereto annexed and by me subscribed
