## Southern Campaigns American Revolution Pension Statements & Rosters

Pension application of Isaac Fairies [Feris, Farris]<sup>1</sup> S3352 f31SC
Transcribed by Will Graves 1/14/09 rev'd 2/2/15 & 1/25/21

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

## State of Tennessee Maury County

On this the 24th day of September 1832 personally appeared in open Court, before the Honorable William B. Reese, one of the Chancellors of the said State in the Court of Chancery now sitting, Isaac Farris a resident of Maury County, State of Tennessee, aged about seventy-five years, who being first duly sworn according to law, doth, on his oath make the following declaration in order to obtain the benefit of the act of Congress of the 7th of June 1832.

That he entered the service of the United States under the following named officers and served as herein stated.

That sometime in the month of August in the year 1777, he volunteered for a tour of duty of forty days, under Col. Thomas Neal [Thomas Neel] in York District South Carolina -- that Thomas Neal [Thomas Neel] the son of the Col. was the Capt. of the company -- that the expedition was against the Swannanoa Indians on the head waters of Broad River in the State of North Carolina -- and that he did serve out the whole period above stated.

That the next duty this applicant performed was in the year 1779 -- when he was drafted for three months from the militia of York District South Carolina, and served that tour under Capt. Andrew Love -- that Thomas Neel was the Col. -- that in this tour he was marched to the head of Ogeechee River in Georgia to guard the frontiers.

That in the same year 1779 he was drafted & did serve another tour of three months under Capt. Andrew Love & Col. Samuel Watson that the Company to which he belonged was encamped ten miles from the city of Charleston where the whole term of service was spent.

That in the year 1780 he was in service the whole of this year until the 7th of February 1781 -- when he was discharged -- which was a short time before the battle of Cowan's Ford [February 1, 1781] on the Catawba River where General Davidson was killed. During this year 1780 he was under General Sumpter [Thomas Sumter] was in the battle of Ramsour's Mill [June 20, 1780], where Col. Moore [John Moore] who commanded the Tories, was defeated. He was also in the battle on the Wateree Creek where Col. Philips was defeated & taken Prisoner Col. James Hawthorn commanded the American forces in this last battle.

He was also in the battle at Biggin Church [July 17, 1781] about 34 miles from the City of Charleston -- Generals Sumter & Marion were both in this last Battle. In this battle the

immediate Capt. of this applicant was John Cunningham.

That he was in the battle near the mouth of Fishing Creek [August 18, 1780], when General Sumter was defeated by Tarleton.

This applicant states that he was born in the State of Pennsylvania sometime in May (about the 22) 1757 -- his father removed to the State of South Carolina when he was about ten years old -- he has seen the registry of his birth & has a copy of the same taken by himself -- That he removed from South Carolina on the 19th of March 1806 & settled in Maury County Tennessee where he has resided ever since. This applicant states further, that he has no living witness in this State as he knows of, by whom to prove his services in the revolutionary war nor has he any papers or other documents by which to establish the above facts.

The said Isaac Faris [sic] hereby relinquishes every claim whatever to a pension or annuity except the present, & declares that his name is not on the Pension Roll of the agency of any State. That he is known to the Rev. Hugh Shaw & Jacob Gillham by whom he can prove his character for veracity & their opinion to his revolutionary services.

The Amended Declaration of Isaac Farris in Order to obtain a pension under the act of Congress June 7th, 1832

State of Tennessee Maury County

This applicant stated in his former declaration that he entered the service in the month of August 1777 & that he served forty days -- that in 1778 he was drafted he now states that on 22 December 1778 he was drafted for the term of three months from the militia of York District South Carolina under Capt. Andrew Love, that Thomas Neel was the Col. of the Regiment & that he did serve the full period of three months as stated in his declaration. That in the month of October 1779, he was again drafted for three months in the same District in South Carolina and in the Company commanded by Capt. Andrew Love & Col. Samuel Watson which term of three months he actually served as mentioned in his first application. On the 2nd day of January 1780 he volunteered in the Regiment commanded by Col. Hawthorn, Col. Brachen [William Bratton?] & Col. Howe alternately & in the company commanded by Capt. Cunningham & that he did continue in the service from the 2nd of January 1780 until the 7th of February 1781 when he was discharged as mentioned in his former declaration. This applicant refers to his former declaration for the particulars of his Service &c and states that in all the service above mentioned he served as a private except in the service of 1780 when he discharged the duties of quarter master for the term of three months.

[p 9: On May 29, 1841, in Maury County, Samuel Whiteside, JP, gave testimony that it had been proved to his satisfaction that Rhoda J. Whiteside, Elizabeth Whiteside, Mary Feris, Isaac R. Feris and Alexander Feris were the only surviving children of Isaac Feris who died 20th day of February 1840 in Maury County, Tennessee.]

[Veteran was pensioned at the rate of \$63.88 per annum commencing March 4<sup>th</sup>, 1831, for service as a private for one-year 7 months and 5 days in the South Carolina militia.]
