Pension application of Robert Reeves S33550 Transcribed by Will Graves f10VA 6/15/12

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call errors or omissions to my attention.]

State of New Jersey Hunterdon County SS: before may James Ewing one of the Judges of the Court of common pleas in said County of Hunterdon personally appeared Robert Reeves of the Township of Hopewell in said County, who being duly sworn &c deposeth and saith that he served in the Revolutionary Army of the United States upwards of 3 years, that he enlisted on the 16th day of February in the year 1776 and Captain Thomas Blackwell's company in the 10th Virginia Regiment then commanded by Colonel Stevens [Edward Stevens], that he enlisted for three years and continued in that Regiment about two years, when he was turned over to the light infantry and attached to the company under Captain Shulton [? Shelton?] under the command of General Wayne where he served until sometime after the expiration of his term, when he was discharged.

Sworn to at Trenton in said County of Hunterdon March 30th, 1818 before me S. Jas. Ewing

[marginal note: "The said Robert Reeves further saith that his discharge has been since lost or destroyed and that he is in such reduced circumstances as to need the assistance of his Country for his support.

State of New Jersey hundred and County: SS

On this 3rd day of August 1820 personally appeared in open court of common pleas, being a court of record in and for the said County Robert Reeves aged 67 years, resident in the Township of Hopewell in said County, who, being 1st duly sworn according to law, doth, on his oath, declare that he served in the Revolutionary War as follows: He enlisted in 1776 in Captain Thomas Blackwell's Company in Colonel Stephen's Regiment in the Virginia line under the Continental establishment for 3 years which he served and was regularly discharged which discharge was lost. Was in the battle of Monmouth [June 28, 1778].

And I do solemnly swear that I was a resident Citizen of the United States on the 18th day of March 1818 and that I have not since that time by gift, sale or in any manner whatever disposed of my property or any part thereof with intent thereby so to diminish it as to bring myself within the provision of an act of Congress entitled "an act to provide for certain persons engaged in the land and naval service of the United States in the revolutionary war" passed on the 18th day of March 1818, and that I have not nor has any person in trust for me any property, or securities, contracts or debts due to me nor have I any income other than what is contained in the schedule hereto annexed and by me subscribed. [Veteran was pensioned at the rate of \$8 per month commencing March 30, 1818, for service as a private in the Virginia Continental line for 3 years.]
