[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

State of Tennessee, Washington County: July Sessions 1834

On this 25<sup>th</sup> day of July 1834 personally appeared in open Court before the Justices of the Court of Pleas & Quarter Sessions for the County & State aforesaid Charles Graham a citizen thereof aged Sixty Eight years who being first duly sworn according to law doth on his oath make the following declaration in order to obtain the benefits of the act of Congress passed the 7<sup>th</sup> June 1832, that he entered the service of the United States in the Revolutionary War under the following named officers and served as hereinafter stated to wit he was born in the State of North Carolina in Guilford County in the year 1766 from the best information he can obtain in the absence of Record evidence of which he is deprived being illiterate & knowing nothing of there ever having been a record of family ages. That his father removed from Guilford North Carolina at an early period of the settlement of the Northwestern territory thereof (now Tennessee) at which time the Cherokee Indians who were in alliance with the British were on the immediate borders of the settlement and making daily incursions killing, depredating [sic] & plundering upon the exposed inhabitants that in the Spring of the year 1781 he volunteered under Captain James Robeson [James Robertson] in Washington County State of Tennessee then North Carolina and John Sevier Lieutenant and was marched to Horton's [could be Hester's] Fort at the Sycamore Shoals on Watauga River where he was stationed in guarding the inroads of the Cherokee Indians from the first day of May until the first of September thereafter being a tour of four months when the forces there were relieved by the arrival of Colonel Christy's [William Christian's Regiment from Virginia.

He states that he returned home soon after being verbally discharged by his Captain Robeson. Again in the following Summer he volunteered under Captain Thomas Wilson for a militia term and was marched to Wilson's Fort on the Great Limestone where he remained under the command of Colonel Sevier in excursions & scouts against the Cherokee Indians from the first of May until October having been less than six months a few days, say 5 ½ months, was discharged verbally by Captain Wilson & returned home. That the continued hostilities of the Indians called for another expedition the ensuing spring & he then volunteered under Captain Wilson & under Col. Sevier & was again marched to the Fort on Limestone & there after frequent skirmishes with the Indians served on that campaign four months & was for verbally discharged by said Captain Wilson. The war having been closed with the British he often served afterwards but for which he claims no compensation. That in the three several tours of duty he served on the whole for thirteen and half months in the Revolution for which he claims a pension. That he has no record evidence of his services nor does he know of any person by whom he can prove his actual service but Allen Gillespie Esqr. & John Stout are known to him & he to them & by whom he can establish the reputation of his services, there being no minister of the gospel in his vicinity by whom he can establish the reputation of service. That he is not on the list of the agency of any state as a pensioner, and he hereby relinquishes every claim whatever to a pension except the present.
