State of New Jersey

Cumberland County Ss.

On this third day of June in the year 1818, before me the subscriber, one of the Judges of the Court of Common Pleas in and for said county, personally appears James Millson aged 64 years, resident in said County who being by me first duly sworn, according to law, doth, on his oath, make the following declaration in order to obtain the provision made by the late act of Congress entitled "An act to provide for certain persons engaged in the land and naval service of the United States in the Revolutionary War" That he the said James Millson enlisted at Choptank Bridge in the State of Maryland in the company commanded by Captain William Haslet of the regiment (he believes the 13<sup>th</sup> Maryland) commanded by Colonel Guest [sic: Mordecai Gist, 3<sup>rd</sup> Maryland Regiment], in the year 1777, that the said company was, after the battle of Germantown [4 Oct 1777] commanded by Lieutenant Thomas Mason, that he continued to serve in the said corps, or in the service of the United States untill the termination of the revolutionary war when he was honorably discharged from service, in the State of Virginia, which discharge is lost That he was in the battles of Brandywine [11 Sep 1777] & Germantown & at the capture of Lord Cornwallis [19 Oct 1781] and that he is in reduced circumstances, and stands in need of the assistance of his country for support, and that he has no other evidence now in his power of his said services.

## STATE OF NEW-JERSEY.

CUMBERLAND COUNTY, Inferior Court of Common Pleas, of the Term of June, Eighteen hundred and Twenty.

On this twenty second day of June 1820, personally appeared in open court, being a court of record for the said county, James Millson, labourer aged sixty six years, resident in Hopewell in said county, who, being first duly sworn, according to law, doth, on his oath, declare that he served in the Revolutionary war as follows: that he enlisted for three years in the year 1777 with Captain Haslet of the 13<sup>th</sup> Regiment Maryland line, and served in the Company until the army was discharged at the Close of the war, when he was honorably discharged, at Norfolk Va. in 178– that he was in the battle of Germantown, (in which he was wounded) Brandywine and the capture of Cornwallis, his declaration to obtain a pension he believes was dated June 3<sup>d</sup> 1818, and his pension certificate is dated November 25<sup>th</sup> 1818 numbered 4.564

And I do solemnly swear that I was a resident Citizen of the United States on the 18<sup>th</sup> day of March 1818 and that I have not since that time by gift sale or in any manner disposed of my property or any part thereof with intent thereby so to diminish it as to bring myself within the provisions of an act of Congress entitled "an act to provide for certain persons engaged in the land and naval service of the United States in the Revolutionary War" passed on the 18<sup>th</sup> day of March 1818 and that I have not nor has any person in trust for me any property or securities contracts or debts due to me nor have I any income other than what is contained in the Schedule hereto annexed and by me subscribed.
