The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

State of Maryland Anne Arundel County April 19th 1818

John Sprigg Belt of the County and State aforesaid appeared before me the Subscriber Associate Judge of the third Judicial District of Maryland and being duly sworn on the Holy Evangels of Almighty God deposes, said and declared that he was appointed and commissioned as a Lieut. in the fourth Maryland Regiment on the Tenth day of December 1776, and was appointed Captain of the said Regiment on the Fifteenth day of December 1777, and served in the War of the Revolution against the Common Enemy from the time first mentioned till the conclusion of the War, the said John Sprigg Belt further deposes, said and declared as aforesaid that from his reduced Circumstances he needs the assistance of his Country for support.

The above Deposition sworn to before me the day and year aforesaid S/ Rich'd Ridgely

I certify that it appears by the Musters of Maryland Troops that John Sprigg Belt entered the Service as a Lieut. on 10th December 1776 & was appointed Captain on the 15th of December 1777 And by the Pay Roll it appears that Captain John Sprigg Belt received Arrears of Pay from the 1st August 1780 to the 15th of November 1783.

I John Sprigg Belt of Anne Arundel County and State of Maryland, do hereby certify that the bearer hereof, Philip Sevoy [sic], "a man of Collour" enlisted as a private in the 4th Maryland Regiment in the Revolutionary War, that to the best of my recollection he continued therein for
