Pension Application of James Currin S34724

On this eleventh day of November 1818, before me the subscriber, one of the associate Judges of the third Judicial District of Maryland for the said district, personally appeared James Currin aged sixty six years, resident in Montgomery County in the said district, in order to obtain the provision made by the late act of Congress, entitled "An act to provide for certain persons engaged in the land and naval service of the United States in the revolutionary war:" That he, the said James Currin enlisted in Montgomery County in the state of Maryland Regt in the company commanded by Captain Loyd Beall [sic: Lloyd Beall] & Col John Gunby of the Maryland line; that he continued to serve in the said corps, or in the service of the United States for the term of three years and two months, when he was discharged from service in Port Tobacco in the state of Maryland, that he was in the battles of Cambden [Battle of Hobkirk Hill near Camden SC, 25 Apr 1781] and Guilford [Guilford Courthouse NC, 15 Mar 1781] and that he received three wounds in the battle of Cambden and that he is in reduced circumstances, and stands in need of the assistance of his country for support; and that he has no other evidence now in his power of his said services.

I hereby relinquish my former pension, agreeably to the act of Congress of the 18th March 1818

The bearer James Curren enlisted with me in the revolutionary War, was wounded at the Second Battle of Campden and lost two of his fingers from his left hand, he has been on the pension list ever since, he enlisted during the War

I hereby Certify that James Current was a soldier in the Maryland line at the action of Camden where he was wounded

given under my hand this 9<sup>th</sup> Oct'r. 1802 [Richard Anderson, pension application S10059]

I hereby Certify that James Currin of Montgomery County & State of Maryland served as a private soldier in the Maryland line, in the Revolutionary War for more than three years.

Given under my hand this 11<sup>th</sup> Nov'r. 1818 Rich'd Anderson late Capt'n. in the Maryland line

Maryland Frederick County SS

On this 26<sup>th</sup> day of October 1820 personally appeared in open court, being a Court of record for Frederick County especially made so by the Laws of the state aforesaid proceeding according to the course of the common law with a Jurisdiction unlimited in point of amount keeping a record of its proceedings & having the power of fine and imprisonment James Currin aged sixty eight years, resident in said county

who being first duly sworn according to law, doth on his oath declare, that he served in the Revolutionary war as follows: In Captain Bells [sic] company of Infantry in the seventh Maryland Regiment commanded by Colonel Gunby that he applied for a pension and obtained a certificate No. 9061 and I do solemnly swear, that I was a resident citizen of the United States on the 18<sup>th</sup> day of March 1818; and that I have not since that time, by gift, sale or in any manner disposed of my property, or any part thereof, with intent thereby so to diminish it as to bring myself within the provision of an act of Congress, entitled, "an act to provide for certain persons engaged in the land and naval service of the United States in the revolutionary war," passed the 18th day of March 1818 and that I have not, nor has any person in trust for me, any property or securities, contracts or debts due to me; nor have I any income other that what is contained in the Schedule hereto annexed, and by me subscribed

And the said James Currin doth also make oath that he is by Occupation a weaver but unable to do any manner of work at this time owing to his being unable to straighten his left arm and the loss of two middle fingers of his left hand at the Battle of Cambden and owing to a hurt received by a fall in his left shoulder some years since that he has no family
