## Southern Campaign American Revolution Pension Statements & Rosters

Pension Application of Antoine Dupille (Anthony Dupile) S34769 Transcribed and annotated by C. Leon Harris.

Anthony Dupile a citizen of the United States and at this time [April 1818] residing in Cecil County in the State of Maryland doth declare that he enlisted in the Service of the United States immediately after the Surrender of Cornwallis [19 Oct 1781] as a common soldier and continued in the said Service in General Eisen's [sic: see endnote] Regiment under Capt'n Coslin and got a discharge at Pumptown plains in New Jersey in the month fo June 1783 after being upward of two years in the service and that he is now too old and poor that he cannot obtain a livelihood for himself and family.

State of Maryland Cecil County Ss.

On this 12<sup>th</sup> day of September 1820 personally appeared in open Court being a court of Record proceeding according to the course of the common Law with unlimited Jurisdiction in point of amount for the said County Antoiene Duppelle aged sixty Seven years resident in the aforesaid County and State who being first duly sworn according to Law doth on his Oath declare that he served in the Revolutionary War as follows; that he enlisted at York Town in Virginia in the Congress Regiment Colo Eizen in Captain Coslins Company as a private in the year of the taking of Cornwallis; that he continued in the service of the United States two years and upwards untill the conclusion of the War, and was discharged at pumptown plains New Jersey, the Certificate of discharge which he obtained is lost: that at the April Court 1818 he made Oath to a declaration to the foregoing effect and obtained a pension thereupon which is numbered 14.073.

And I do solemnly swear that I was a resident Citizen of the United States on the 18<sup>th</sup> day of March 1818 and that I have not since that time by gift sale or in any manner disposed of my property or any part thereof with intent thereby so to diminish it as to bring myself within the provisions of an act of Congress entitled "an act to provide for certain persons engaged in the land and naval service of the United States in the Revolutionary War" passed on the 18<sup>th</sup> day of March 1818 and that I have not nor has any person in trust for me any property or securities contracts or debts due to me nor have I any income other than what is contained in the Schedule hereto annexed and by me subscribed.

That I have been a labourer, but by reason of old age and infirmity am unable to support myself and wife aged Seventy eight years having no Children living with me – Antoine Dupille

NOTE: Although the file jacket is labeled "Va.," it appears that Dupile was actually in Gen. Moses Hazen's Canadian Regiment, also known as "Congress's Own Regiment." In French the H in Hazen's name is silent.
