[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

## State of Maryland First Judicial District

On the first day of April 1818 personally appeared Archibald Johnson of Charles County before the subscriber the Chief Judge of the above district in which Charles County is included and made oath on the holy evangelists of Almighty God that in the Spring of the year 1779, he enlisted as a soldier in the first Maryland Regiment, and that he was placed in Capt. Henry Gaither's Company and promoted to the rank of Sergeant in the same year, that he was transferred at different periods in the same grade from one company to another in consequence of casualties by which the companies were reduced; that he continued to serve to the end of the war, and returned with the balance of the Maryland line from the southward in the year 1783 and was discharged at the City of Annapolis in the fall of that year.

The said Johnson also made oath that in the winter of the year 1782 he was appointed a deputy forage master in the southern department and continued to act as such until the Continental forces were sold and disposed of. That he is now poor and needy and stands in the need of the assistance of the United States.

On the above date appeared also Robert Halkerston<sup>2</sup> and made oath that he knew the above mentioned Archibald Johnson to have been a soldier in the revolutionary war. Sworn to before the subscriber the Chief Judge of the first Judicial district

[p 8: On October 6, 1828 in the District of Columbia, Pamela Dixon, daughter of Archibald Johnson filed a power of attorney seeking the bounty land due her father for his service in the revolutionary war; the court found that the veteran died August 20<sup>th</sup>, 1818 in Charles County Maryland leaving no widow and that Pamela Dixon, the widow of John Dixon, and Thomas Johnson now of Frederick County Maryland are the reputed and only heirs at law of the said Archibald Johnson.]

[Veteran was pensioned at the rate of \$8 per month commencing April 1, 1818, for service as a Sgt. in the Maryland Continental line.]

succeeding Congresses (March 4, 1843-March 3, 1851); chairman, Committee on Roads and Canals (Thirtieth Congress); was not a candidate for renomination; Minister to Brazil and also accredited to Uruguay, Argentine Confederation, and Paraguay, 1851-1853; entered the Union Army May 17, 1861, and served as brigadier general of Volunteers; promoted to major general September 18, 1862, to date from August 30, 1862; resigned his commission in the Army on December 3, 1863, to take his seat in Congress; elected as a Republican to the Thirty-eighth and to the three succeeding Congresses and served from March 4, 1863, to January 5, 1871, when he resigned to accept a position in the diplomatic service; chairman, Committee on Military Affairs (Thirty-eighth and Thirty-ninth Congresses), Committee on Ways and Means (Fortieth and Forty-first Congresses); unsuccessful candidate for reelection in 1870 to the Forty-second Congress; Minister to Great Britain from December 1870 until March 1876, when he resigned; delegate to the Philadelphia Loyalist Convention in 1866; member of the Alabama Claims Commission in 1871; resumed the practice of law in Washington, D.C., where he died March 23, 1890; interment in Woodland Cemetery, Dayton, Ohio. http://bioguide.congress.gov/scripts/biodisplay.pl?index=S000118
