[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

State of Mississippi, County of Jefferson

I Solomon Johnson [sic] aged sixty-five years, who upon oath testify and declare, that I entered the service in 1780 for the term of during the war in the Regiment commanded by Colonel Charles Pinckney [Charles Cotesworth Pinckney] in the line or State of South Carolina and continued therein until the close of the war in 1783, and was discharged from the Regiment commanded by Colonel \_\_ Mayem or Maim [probably Hezekiah Maham] of the line or State of South Carolina. I further declare that I have neither received assigned or transferred my claim in any manner whatever: Therefore, I request the Secretary of War to have the warrant sent to me at Petit Gulf Jefferson County Mississippi State and this shall be his receipt for the same before me the 18th of December 1827.

## Original Claim

Declaration in order to be placed on the Pension list under the Act of the 18<sup>th</sup> of March 1818 County of Jefferson: SS

On this twelfth day of May 1827 Personally appeared in Open Court (being a Court of record for the County aforesaid) Solomon Johnson a resident in said County aged sixty-four years who being first duly sworn according to law, doth on his oath make the following declaration in order to obtain the provision made by the act of Congress of the 18th of March 1818 and the first of May 1820; that he the said Solomon Johnson enlisted for the term of three years on the \_\_ day of\_\_ in the year 1777 in the State of South Carolina in the company commanded by Capt. James Ichburg in the Regiment commanded by Col. Thomas Sumpter [sic, Thomas Sumter] in the line of the State of South Carolina in the Continental Establishment: he continued to serve in said Corps until the 12th day of May 1780 when he was taken prisoner by the British Army at Fort Moultrie; that he the said Solomon Johnson was discharged on parole by the commanding officer of the British Army, and again enlisted for the term of two years on the 18th day of August 1780 in the State of South Carolina in the Company commanded by Capt. Robert McElvy in the Regiment commanded by Col. Mayham [Hezekiah Maham] in the line of the State of South Carolina on the Continental establishment; and that he continued to serve in said Corps until the 20th day of August 1782 when he was discharged from the service, in the

State of South Carolina: that he hereby relinquishes every claim whatever to a pension except the present; that his name is not on the roll of any State, except South Carolina and that the following are the reasons for not making earlier application for a pension because he was able to support himself and family by his own manual exertions which he is now unable to do by reason of his feebleness. And in pursuance of the act of the first of May 1820, I do solemnly swear that I was a resident Citizen of the United States on the 18<sup>th</sup> day of March 1818 and that I have not since that time by gift, sale or other wise disposed of my property or any part thereof with intent thereby so to diminish it as to bring myself within the provision of an act of Congress entitled "an act to provide for certain persons engaged in the land and naval service of the United States in the revolutionary war" passed on the 18<sup>th</sup> day of March 1818, and that I have not nor has any person in trust for me any property, or securities, contracts or debts due to me nor have I any income other than what is contained in the schedule hereto annexed and by me subscribed to wit

six head of cattle of the value of thirty dollars

That since 18 March 1818 the following changes have been made in my property eight head of horned cattle which have been consumed in sustaining myself and family and fifteen head of hogs which have been consumed in like manner.

That Said Solomon further states that he has but two children to wit Elizabeth [illegible] neither of whom reside with him at this time and that he has always pursued the occupation of a farmer until the weakness of his body compelled him to cease labor.

To James L Edwards Esquire: Rodney January 30, 1843 Honorable Sir,

Being appraised that you are a Commissioner of pensions of the United States And having served as a soldier in our Army's from the earliest period of our Countries' Struggles for independence until the restoration of peace, I avail myself of this opportunity (in my advanced stage of life, being 87 years of age) by means of an amanuensis, to confer with you upon the subject of my pension to which I beg leave to call your attention for a few moments. After having made application, I have received at the rate of ninety-six dollars per year from the year 1826 to the present. I am told that the law for remunerating Revolutionary pensioners took effect previous to 1826. If so I must be entitled to \$96 per year or at that rate for all the time intervening between the time that the act took effect, and the date of my first receipt, which is in the pension office. You will please to examine those records, and informed me of the amount of money due me in arrears: also the proper mode of procedure to obtain the same.

Please to direct a letter containing the above requisite information to me or my agent at Rodney Jefferson County Mississippi and oblige a Revolutionary Soldier.
