Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

State of Illinois County of Pope: Sct.

On this first day of November in the year of our Lord 1826 personally appeared in open court to wit the Circuit Court in and for the County of Pope and State of Illinois, being a court of record, David McNeely a resident of said County aged about seventy-three years, who being first duly sworn according to law doth on his oath make the following declaration in order to obtain the provision made by the act of Congress of the 18th of March 1818 and the first May 1820. That he the said David McNeely enlisted for the term of three years on the day of April in the year 1777, in the State of Virginia, in the Company commanded by Captain Adam Wallace, in the 7th Regiment commanded by Colonel Heath [William Heth], in the line of the State of Virginia on the Continental establishment. That he continued to serve in the said Corps until the day of in the year 1779, when he was discharged honorably from service, in the State of North Carolina. That he hereby relinquishes every claim whatever to a pension except the present. That his name is not on the roll of any State and that the following all the reasons for not making earlier application for a pension viz.: That until within a short time he has been (although without property) able to support himself comfortably, by his labor, but that now from age and infirmity he is entirely unable to gain a support by work, and is therefore compelled to solicit his Country's aid – And in pursuance of the act of the first of May 1820, I do solemnly swear that I was a resident Citizen of the United States on the 18th day of March 1818 and that I have not since that time by gift, sale or in any manner whatever disposed of my property or any part thereof with intent thereby so to diminish it as to bring myself within the provision of an act of Congress entitled "an act to provide for certain persons engaged in the land and naval service of the United States in the revolutionary war" passed on the 18th day of March 1818, and that I have not nor has any person in trust for me any property, or securities, contracts or debts due to me nor have I any income whatever – That ever since the 18th day of March 1818, there has been no change in my property. I am a laborer (when able) and have no family whatever.

This 19th day of September 1826 personally appeared before William Farris an acting Justice of the peace in and for the said County, John G Simpkins² and Samuel Gardner and made

oath That David McNeilly who is about to apply for a pension as a Revolutionary Soldier was personally known by them as a Soldier in the revolutionary war, on Continental establishment, between the year 1777 and 1779, that the said David McNeilly enlisted sometime in the month of April 1777 for the period of 3 years in the State of Virginia in the company commanded by Captain Adam Wallace in the 7th Regiment commanded by Colonel Heath, in the line of the State of Virginia, on the Continental Establishment, and was honorably discharged from said Service sometime in the year 1779 in the State of North Carolina. They further make oath that they knew the said David McNeely in the service aforesaid at Valley Forge and at Eutaw Springs &c/
