Pension application of Jesse Peak S35557 Transcribed by Will Graves f19VA 9/30/12

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call errors or omissions to my attention.]

Jesse Peak an applicant for a pension under the several acts of Congress appeared in Court and made & subscribed the written Declaration of the time and manner of his entering into the service of the United States & made oath to the correctness of the same which ordered to be recorded and the same follows in these words to wit. On the 13th day of August in the year 1822 appeared Jesse Peak before the Honorable John L Bridges one of the Judges of the Circuit Courts of the State of Kentucky especially assigned to the Circuit Court for Lincoln County in the State aforesaid in open court, the said court being by act of assembly a court of Record, receiving according to the course of the Common law and being first sworn, with the view of the perfecting his claim to a pension under the act of Congress of March 1818 stated that he is now about 58 years old; that he is now & has been constantly for the last 15 years a resident of the County of Lincoln above mentioned; that he is now & has ever been a citizen of the United States since the Declaration of Independence in the year 1776 and that the facts stated by him in his affidavit before Thomas Montgomery one of the Circuit Judges of the State of Kentucky on the 4th day of September A.D. 1819 respecting his services, enlistment discharge &c as a Soldier in the regular Army of the United States on the Continental establishment are true; that the said affidavit is now before him and is authenticated by the certificate of Thomas Helm Clerk of the Court aforesaid with the Office seal of the said Court and follows in these words (viz.) State of Kentucky Sct. I Thomas Montgomery one of the Judges of the Circuit Court in and for the State aforesaid particularly assigned to the Circuit Court of Lincoln County do hereby certify that on this date Jesse Peak of Lincoln County aforesaid aged about 55 years personally appeared before me and being duly sworn by me with the view of obtaining a pension according to the provisions of the Act of Congress passed in March 1818 stated that some 6 or 8 months before the battle of Guilford courthouse N. C. [March 15, 1781] he enlisted as a regular soldier in the War of the Revolution between Great Britain and the now United States of America for the Term of eighteen months, that his Captain's name he does not now recollect but his Regiment was commanded by Colonel Abraham Buford, but who commanded the Brigade he does not recollect; that he was in the battle of Guilford Court house aforesaid under the aforesaid enlistment. That the second day after the said Battle, he enlisted for the whole war with Captain Churchwell Jones and served in the Corps of cavalry commanded by Colonel William Washington: that he continued in the Army & faithfully performed his duties until the close of the War and was discharged in Winchester Virginia, but which discharge has been destroyed by accident. That he verily believes that he was on the Continental establishment and as he believes of the Virginia line: that he is now poor & reduced in his circumstances & really needs the aid proposed in the act of Congress before mentioned and does claim it.

I do certify further that at the same time Charlton Shockley a relation of the said Jesse

Peak, also appeared before me and being duly sworn, states that he knows that the said Jesse Peak went into the service as a soldier was a long time absent and during his absence reputed to be a regular soldier constantly. Given under my hand as one of the Judges of the circuit Courts aforesaid the 14th day of September A.D. 1819.

He states further upon his oath that he is now and has constantly since the Declaration of Independence in the year 1776 been a citizen of the United States and that he has not since the passing of the before recited act of Congress made any gift sale or conveyance or transfer of any money property rights of action or thing legal or equitable touching or relating to the realty or personalty with the view of reducing his circumstances so as to bring himself within the provisions of the before mentioned act of Congress, and that he has not at this time any money or property real, personal or mixed in possession reversion or remainder, or any rights by bond, covenant or assumpset, or any rights by apiration of law, or any money or property of any kind holden by others in trust for him other than what is mentioned in the schedule following to wit one cow & calf the value of both not exceeding the sum of \$75 – two beds & furniture worth the sum of \$40 and not more. Five hogs of about the value of \$10 and not more. That he is much afflicted with Rheumatic pains and able to perform but little labor. That his occupation has always been that of a cultivator. That he is the father of five children who have all arrived to mature years, have married and left him, that his Wife is still alive but a good deal in from of body; that he really is reduced in his circumstances, and does need the benefit of the provision proposed to be given by the before mentioned act of Congress and does hereby request the same. [Veteran was pensioned at the rate of \$8 per month commencing September 4th, 1819, for service as a private in the Virginia Continental line.]

Lincoln County Kentucky Sct.

Jesse Peek [sic] this day personally appeared before me H. Thurman a Justice of the peace for the said County and made oath that he enlisted in Virginia in the fore part of the year 1781 for during the war in Captain Churchwell Jones's third troop of Cavalry or Light dragoons in the third Virginia Regiment or Continental line commanded by Colonel William Washington and that he continued to serve in said service until the final ratification of peace was signed in 1783 at which time he was honorably discharged at Winchester in Virginia and through the course of time he has lost his discharge and has never received his land warrant for said services.
