Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call errors or omissions to my attention.]

Before me the subscriber one of the Judges of the General Court, and a Circuit Judge for the State aforesaid on this 22nd day of November in the year 1819, personally appeared Nathaniel Raine a citizen of Bourbon County in said State, aged about sixty-two years, and being sworn according to law did make the following declaration and Statement pursuant to the Act of Congress in favor of Revolutionary claimants approved the 18th day of March 1818, to wit,

That he was enlisted as a soldier in the Continental Army of the Revolution, in or about the month of February 1776 at Cumberland County Virginia in the Company commanded by Captain John Morton, of the 4th Virginia Regiment commanded by Lieutenant Colonel Robert Lawson, and Colonel Reed [Isaac Read] – to which Regiment he was attached, and was attached to the Brigade commanded by General Charles Scott; that said period of enlistment was two years, and that he faithfully served out that period, and was honorably discharged at the Valley Forge in Pennsylvania, in 1778 by General Charles Scott, which discharge he has lost & can only produce the evidence herewith transmitted. That he yet has a wife to support, and has no estate beyond the horse and his wearing apparel having still hitherto supported himself & wife by what labor he could perform and that he is in such reduced circumstances as to require the aid of his country as provided by law.

Also at the same time and place Moses Sharp¹ being sworn according to law did depose and say, That he was acquainted with the above named Captain Nathaniel Raine previous to the year 1776 being raised children together with him – that he himself was enlisted and did serve in the same company with the said Raine, his enlistment was about four days after that of Raine – That he knows of the said Raine's being enlisted and serving in the same company until they were both discharged together in the spring 1778 – That this deponent was with him all the time of said two years in service except in the fall 1776 this deponent fell sick, on the expedition to the North, and was left behind until his recovery which was near the following spring when this deponent again joined the same company & found Raine there in service, in which he continued till the discharge aforesaid detailed by Raine.

Commonwealth of Kentucky and Circuit of Bourbon: SS

On this 29 August 1820 personally appeared in Open Court held in and for the Circuit aforesaid being a Court of record, Nathaniel Raine aged sixty-three years resident in Bourbon County and Circuit aforesaid, who being duly sworn according to law doth on his oath depose and say, that he is the same Nathaniel Raine who served in the revolutionary war as detailed in his original declaration dated on the 22nd November 1819 – & now on file in the war office, in pursuance of which he has been inscribed on the pension list roll of the Kentucky agency and hold a certificate thereof bearing date the 5 June 1820 – No. 17,382.

And he solemnly swears that he was a resident Citizen of the United States on the 18th day of March 1818 and that he has not since that time by gift, sale or in any manner whatever disposed of his property or any part thereof with intent thereby so to diminish it as to bring himself within the provision of an act of Congress entitled "an act to provide for certain persons engaged in the land and naval service of the United States in the revolutionary war" passed on the 18th day of March 1818, and that he has not nor has any person in trust for me any property, or securities, contracts or debts due to him nor has he any income other than what is contained in the schedule hereto annexed and by him subscribed, his wearing apparel & bedding excepted
