Sussex County ss. } On this fifteenth day of November in the year of our Lord eighteen hundred and nineteen, before me the subscriber, one of the Judges of the
Supreme Court, in and for the said District or State of Delaware, personally appeared Aaron Easor aged between seventy and eighty years, resident in said District of Delaware (Sussex County), who being by me first duly sworn according to Law, doth on his oath, make the following declaration, in order to obtain the provision made by the late act of Congress, entitled "An act to provide for certain persons engaged in the land and naval service of the United States in the revolutionary war": That he the said Aaron Easor inlisted for the term of and during the Revolutionary war, on the [blank] day of [bank] in the year seventeen hundred and seventy seven, in the County of Sussex, in the State of Delaware, in the company commanded by Captain [Robert] Kirkwood, of the Delaware Regiment commanded by Col. David Hall, sometimes by a Major Patten [sic: John Patton] & Col. Lawrence [sic: John Laurens], in the line, on the Continental Establishment; that he continued to serve in the said corps, or in the service of the United States, untill the conclusion of the war, when he was discharged from the service in New Castle, in the State of Delaware, that he was in the battles of the Cowpens [SC, 17 Jan 1781], Guilford [Guilford Courthouse NC, 15 Mar 1781], at Camden [either Battle of Camden SC on 16 Aug 1780 or Battle of Hobkirk Hill near Camden on 25 Apr 1781], and at Little York at the taking of Cornwallis [19 Oct 1781] &c. – And that he is in reduced circumstances, and stands in need of the assistance of his country for support; and that he has no other evidence now in his power of his said services.

State of Delaware } Sussex County ss. } Be it Remembered that on the sixteenth day of November in the year of our Lord eighteen hundred and nineteen, Mitchell Lecatts [Mitchell Lecatt, pension application S36040] aged sixty two years, personally appeared before me Samuel Paynter Jun'r. one of the Judges of the Supreme Court of the State of Delaware who being solemnly sworn on the Holy Evangels of Almighty god, did depose and say that he knew Aaron Easor in the foregoing Deposition named, an inhabitant of Sussex County, and has known him from the year seventeen hundred and seventy eight, and that he was at that time a Soldier in the Delaware Regiment, and continued in the said Regiment to the knowledge of this Deponent untill they were discharged by a Resolve of Congress at the conclusion of the Revolutionary War, and during the time of about five years that he served in the said regiment with this Deponent, he done faithful duty Mitchell hisXmark Lecatts
State of Delaware } Sussex County ss. } Be it remembered that on the seventeenth day of November in the Year of our Lord Eighteen hundred and nineteen, Edward Harmon [S36000] of the County of Sussex and State aforesaid aged about sixty years, Personally appeared before me Samuel Paynter Jun'r. one of the Judges of the Supreme Court of the State of Delaware, who being solemnly sworn on the Holy Evangels of Almighty God, did Depose and say that he has known Aaron Easor in the foregoing Depositions named, an inhabitant of Sussex County afs'd. before the commencement of the Revolutionary war, and that in the year seventeen hundred and seventy seven, he inlisted in the company commanded by Captain Kirkwood in the Delaware Regiment, commanded by Col. David Hall, and occasionally by Col. Laurence and Col. [William] Washington, and continued in the service of the

United States untill the conclusion of the war, when he was discharged by general proclamation, and

from the time of his enlistment to his discharge in the southern states, in the Army commanded by Generals, [Horatio] Gates and Green [sic: Nathanael Greene].

On this the tenth day of April one thousand eight hundred and twenty one, personally appeared in open Court, the Court of Common Pleas of the State of Delaware, sitting in and for the County of Sussex, (it being a court of record, having the power of fine and imprisonment) Aaron Easor, aged about eighty years, resident in Dagsborough Hundred in the said County, who being first duly sworn according to law, doth on his oath declare, that he served in the Revolutionary War as follows, in the Delaware Regiment, in the Company of Captain Kirkwood in the Delaware Line. The first declaration made by this deponent was on the fifteenth day of November one thousand eight hundred and nineteen, and the pension he has received has been on the pension certificate No. 16,134. And I do solemnly swear that I was a resident citizen of the United States on the eighteenth of March, one thousand, eight hundred and eighteen, that I have not since that time by gift sale, or in any manner, disposed of my property or any part thereof, with intent there by to diminish it so as to bring myself within the provisions of an Act of Congress, entitled "an act to provide for certain persons engaged in the land and naval service of the United States in the Revolutionary War", passed on the eighteenth day of March one thousand eight hundred and eighteen, and that I have not, nor has any person in trust for me, any property, or securities, contracts or debts, due to me nor have I any income, other than what is contained in the schedule here to annexed and by me subscribed
