## Floyd County State of Kentucky

Isaac Fleetwood an old Revelutionary Soldier Seventy five years of age states that he enlisted in the survice of the United States in the year 1776 for the time of three years or in dureing the war and he states that he was in the Battle of Brandawine [sic: Brandywine, 11 Sep 1777] and the Battle of White Marsh [Whitemarsh, 5 Dec 1777] and Continued in the service for the service for the terme of four years in the Eleventh Virginia Redgement Commanded by Col Fabaker [sic: Christian Febiger] in Captain William Smiths Company and was honourably Discharged in the year 1780 and he states that he has lost his discharge and know not whear nor when and also states that it is from his age and infirmities and indignent Circumstance in property that he Claims the asistence of his Country agreeable to the Act of Congress approved the 18th day of March 1818

State of Kentucky Floyd County Sct.

At a court held for Floyd County at the Courthouse in Prestensburg [sic: Prestonsburg] on Monday the 27<sup>th</sup> day of January 1823 Isaac Fleetwood an old Revolutionary soldier produced in open court a schedule of his property which is in the following words and figures to wit.

State of Kentucky Floyd County Sct.

January term 1823 this day personally appeared in open court this being made a court of record by the laws of this state being solemly adjudged to be such by the other tribunals of this state with power to fine and imprission always keeping a record of its proceedings Isaac Fleetwood aged about 78 years a resident citizen of the county aforesaid and in persuance of an act of congress approved the 18th day of March 1818 providing for certain persons engaged in the land and naval service of the united states in the revolutionary war and also in pursuance to an act of congress approved the 1st of May 1820 entitled an act in addition to an act entitled an act to provide for certain persons engagued in the land and naval service of the united states in the revolutionary War passed on the 18th day of March 1818 upon his oath doath solemly declare that he enlisted in the service of the united in the armey of the revolutionary war against the common enemy in the year 1776 for the term of three years as enduring the war and that he was enlisted in Lawden [sic: Loudoun] County in the State of Virginia in the Virginia line in a company commanded by Cap'n. Wm. Smith in a Regiment commanded at that time by Col [Daniel] Morgan and afterwards by Col. Fabaker in Virginia line and continental establishment. that he continued to serve in the army of the revolutionary war in the service of the united States four years at the end of which time he was honourably discharged which was the 1780 at the Valley Forge which discharge he has lost or mislaid and that he was in the following Battels to wit. the battle at Jermantown the battle at Malmouth [sic: Monmouth, 28 Jun 1778] that he has no other evidence of his service except the deposition of John Smith [W8731] an old revolutionary Soldier and the other depositions herein filed and Transmitted to be made his original declaration and application for a pension on the 16<sup>th</sup> day of June 1818 but has not as yet received his pension certificate which decleration is refered to marked A which is herewith transmited. and he also doth declare on oath that he was a resident citizen of the united states on the 18th day of March 1818 and that he has not since that time by gift sale or in any manner disposed of his property or any part thereof with intent thereby so to diminish it as to bring himself within the provisions of an act of Congress entitled "an act to provide for certain persons engaged in the land and naval service of the United States in the Revolutionary War" passed on the 18th day of March 1818 and that he has not nor has any person in trust for him any property or securities contracts or debts due to him nor has he any income other than what is contained in the Schedule hereto annexed and by him subscribed. Viz. one

little mare worth \$25. two little heiffers worth seven dollars each \$14. eleven head of hogs worth \$20. one pot worth \$1.50 cts one oven worth 300 cts. two axes worth one dollar each \$2. three old hoes worth \$1. and that he has no other property either real or personal his occupation is that of a farrier but he is two old and inferm to persue it. his family consists in a wife aged about forty five years and three small children which is unable to contribute any thing for his support and it is from his reduced circumstances in live and inabilities to labour that he claims the assistance of his country

## State of Kentucky [Pike] County sct [3 Oct 1823]

here follows the Deposition of Joseph Boney an old Revolutionary soldier about seventy two years of age States upon oath after being duly sworne before the subscriber one of the Commonwealths Justices of the peace for said County that he knew Isaac Fleetwood the present applicant to be an enlisted soldier for the terme of three years or endureing the war this deponent knows that the said Isaac Fleetwood did serve under said enlistment for upwards of two years in the army of the Revolutionary War on Continental Establishment dureing which time this deponent was well acquainted with the said Isaac Fleetwood this deponent further states that he knows that the said Isaac Fleetwood did serve dureing the said terme of two years or upwards that this deponent knew him in the Army of the Revolutionary under enlistment this deponent and the said Isaac Fleetwood had their winter quarters together at Valley Forge and then they marched marched from there in persuance of the Brittish Army and overtook them at Manmouth Courthouse in Jersey State an had a Battl there and the fall after the Battle this deponen marched with the army to the South and left the said Fleetwood and at that time this deponent got parted from the said Fleetwood and never seen him any more untill after the close of the war Joseph hisBmark Bonney

NOTE: On 2 Feb 1828 Isaac Fleetwood, 96, having moved in early Oct 1827 to Lawrence County Indiana, applied to have his pension transferred to that state because "he is old and unable to ride to Lexington Kentucky (without much inconvenience to himself) in consequence of pains rheumatism and bodily infirmity." This application was certified by James Fleetwood, John Fleetwood, and others.

was enlisted in Lawden [sic Loudon?] county in the state of Virginia in the Virginia line in a company commanded by Capt Wm Smith in a regiment commanded at that time by Col Morgan and afterwards by Col Fabaker [sic Christian Febiger] in Virginia line and Continental establishment. That he continued to serve in the army of the revolutionary war in the service of the United States four years at the end of which time he was honourably discharged which was the 1780 at the Valley Forge which discharge he has lost or mislaid. And that he was in the following battles to wit: the battle at Germantown, the battle at Malmouth [sic Monmouth]. That he has

[p6] no other evidence of his service except the deposition of John Smith an old revolutionary soldier and the other deposition herein filed and transmitted to be made his original declaration and application for a pension on the 16<sup>th</sup> day of June 1818 but has not as vet received his pension certificate which declaration is referred to marker #1 which is herewith transmitted. And he also doth declare on oath that he was a resident citizen of the United States on the 18<sup>th</sup> day of March 1818 and that he has not since that time by gift sale or in any manner whatever disposed of his property or any part thereof with an intent thereby to diminish it as to bring myself in the provisions of an act of congress entitled an act to provide for certain persons engaged in the land and naval service of the United States in the revolutionary war passed on the 18<sup>th</sup> day of March 1818 and that I have not nor has any person in trust for me any property securities contracts or debts due me nor have I any income other than what is contained in the schedule annexed & by me subscribed viz: one little mare worth \$25, two little heifers woth seven dollars each \$14, eleven head of hogs worth \$20 one pot worth \$1.50 cts one oven worth 300 cts two axes worth one dollar each \$2, three old hoes worth \$1 and that he has no other property either real or personal. His occupation is that of a farrier but he is too old and infirm to pursue it. His family consists of a wife aged about forty five years and three small children which is unable to contribute any thing for his support.
