I John Forrester do state that I served as a private soldier in the continental army of the United States in the Revolutionary War with great Britain

I do state that in the year 1776 as well as I now recollect being now in the 78<sup>th</sup> year of my age, that I inlisted as a private soldier for three years under Capt John Ashby in the third Virginia Continental Reg't. commanded by Colo. [Hugh] Mercer – that I served out said time of three years and was honorably discharged, that I afterward enlisted under Capt Triplet [sic: Francis Triplett] in Colo. [Daniel] Morgan Rifle Regiment and continued in the service of the united states in s'd Regiment until the end of the s'd War. I enlisted in the s'd Rifle Regiment as well as I recollect in the year 1780. I further state, that I have lost my discharge but how or when I am unable to say.

I further state, that I have always been a Citizen of the United states of America, and that I am now a citizen of the said County of Barren & State af'd. and that I have never taken part against the said United States in any contest whatever. I do further state, that from my reduced circumstances, that I stand in need of the assistance of my Country. I do hereby release to the said United States all and any pension or provisions heretofore allowed or made me by any law of the s'd United States. Given under my hand this 16<sup>th</sup> June 1818

On this 17<sup>th</sup> day of July 1820 personally appeared in Open Court (being a Court of Record for the State and County aforesaid) John Forrester aged 81 years; resident in the County afs'd. a Farmer by occupation and able to work, has no famely except Mary Forester his Wife who is 84 years of age) who being first duly sworn according to Law doth on his Oath declare that he served in the revolutionary War as follows that in the year 1776 he enlisted as a private Soldier for three years under Capt'n. John Ashby in the 3<sup>rd</sup> Virginia Continental regiment Commanded by Colo. Mercer. that he served out said time of three years and was honorably discharged, and that he afterwards enlisted under Captain Triplett in Colo. Morgans Rifle Regiment; as well as he now recollects, in the year 1780 and that he has lost his discharge; and that he never has Received a pension from the United States, and that he was a resident Citizen of the United States on the 18th day of March 1818 and that he has not since that time by gift sale or in any manner disposed of his property or any part thereof with intent thereby so to diminish it as to bring himself within the provisions of an act of Congress entitled "an act to provide for certain persons engaged in the Land and Navel service of the United States in the Revolutionary War" passed on the 18th day of March 1818 and that he has not nor has any person in trust for him any property or securities contracts or debts due to him nor has he any income other than what is contained in the Schedule hereto annexed and by him subscribed, Towit one Old Mare and Colt. a Milch Cow & Calf & a heifer

That he was well acquainted with John Forrester about the year 1776 when this deponent did enter the service of the United States under Capt John Ashby. That the said Forrester was absent from his house in the

County of Fauquier and State of Virginia for several years. To wit for more than two years. This deponent is of opinion from the best recollection which he has that Ashby's men were enlisted for 3 years, and this deponent always understood in the neighborhood that John Forrester did serve out his time without any complaint whatsoever.



[Ed note: In 1845, some post masters began selling covers (envelopes). Typical postage rates were 5 cents additional collected by the sending post master and attested by his signature or the seal (stamp) of his office. In 1847, postage stamps were first issued to replace the post master's signature as proof of payment. The rates were five and ten cents. Much mail to and from DC was still carried by congressmen. Official court seals were still usually stamped into affixed melted wax.]
