## Pension application of Charles Hagan S36008 Transcribed by Will Graves

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

### District of Indiana SS

On this 17<sup>th</sup> day of August 1825 personally appeared in open Court being the Circuit Court of Jackson County in the second Judicial Circuit in the State of Indiana and being a Court of Record Charles Hagan aged sixty-five years and seven months Resident in the County and State aforesaid who being first duly sworn according to law doth on his oath declare that he served in the Revolutionary War as follows. That he enlisted on the 18<sup>th</sup> day of February 1777 in Fairfax County State of Virginia for three years in the Company commanded by Captain Triplett in the 16<sup>th</sup> Regiment Virginia line Continental establishment commanded by Colonel Grayson. That he served three years all to two days and was Discharged at Fredericksburg Virginia by Lieutenant James Winchester on the 16<sup>th</sup> day of February 1780. That he was in the battle of Brandywine [September 11, 1777], Germantown [October 4, 1777] and Monmouth [June 28, 1778], and in many skirmishes and scouts.

And I do solemnly swear that I was a resident Citizen of the United States on the 18<sup>th</sup> day of March 1818 and that I have not since that time by gift, sale or in any manner whatsoever disposed of my property or any part thereof with intent thereby so to diminish it as to bring myself within the provision of an act of Congress entitled "an act to provide for certain persons engaged in the land and naval service of the United States in the revolutionary war" passed on the 18<sup>th</sup> day of March 1818, and that I have not nor has any person in trust for me any property, or securities, contracts or debts due to me nor have I any income other than what is contained in the schedule hereto annexed and by me subscribed

I am by occupation a Brick maker and Brick layer but wholly unable to pursue my trade from having my thigh broke and thereby rendered a cripple so that I am unable to get about without the assistance of crutches and in fact utterly unable to perform any business for the support of myself and family. Susannah my wife nearly 46 years of age of a weakly constitution and unable to do much labor: Julitann my Daughter 13 years of age and very small of her age, but as able to labor as common for Girls of her age and size, George between 10 & 11 years of age as able to labor as boys of his age usually are of his age & size, Isaac 6 years old not able to perform any Business.

### Schedule of Property

14 acres and 139 poles of Land paid for with improvements 80 acres of land entered on which there is \$40 paid and cannot sell said last mentioned 80 acres land for a sum sufficient to pay it

out with the Government. One unimproved lot in the Town of Charleston Clark County Indiana, one cow and two yearlings, two shoats, two tables, one sewing stand, one desk, one pair saddle bags, eight chairs, one tea board, two small glass waiters, one looking glass, one skillet, four stone jars, & 2 water buckets, one Broakin [broken?] Pot, one small oven, four leather horse collars, one tea kettle, one set teaspoons, four plates, four cups and saucers, one ax and coffee mill, \$40 in cash in all that is owing to me the recovery of which I haven't any expectation of succeeding in and \$12 in trade and I owe about \$59.50 in cash

It is the opinion of the court that the value of the above property is  $$139.12 \frac{1}{2}$ .

[Transcriber's note: Most of the papers in this file relate to the veteran's business dealings and debts whereby the veteran attempted to prove that he was indigent and therefore qualified under the 1818 and 1820 pension acts. I have elected not to try to transcribe those but they may be of interest in his descendants and historians interested in business dealings during the early 1800's. The file also contains several other applications and a petition to Congress, but those to do add any details to the veteran's military service. In an application filed on April 3, 1827, the veteran included the following account of his family at that time: "...my family consists of my wife nearly 47 years old of a weekly [sic] constitution unabled [sic] to do much labour, my Daughter Julia Ann aged 14 small of her Age but as able to labour as Girls of her age and size usually are, George my son 12 years of Age as able to labour as boys of his age usually are; my son Isaac nine years old not able to perform any business; And an infant son thirteen months old."]

[Veteran was pensioned at the rate of \$8 per month commencing May 7, 1831, for service as a private for 3 years in the Virginia Continental line.]
