## Pension application of William Lloyd S36049 Transcribed by Will Graves

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

State of Kentucky Fayette County Sct.

This day William Lloyd appeared before me a Circuit Judge for the State of Kentucky and made oath that he was in the Continental service in the Revolutionary War against Great Britain for the space of three years in the company commanded by Gabriel Long of Culpeper County Virginia that he enlisted as a Soldier in the County of Culpeper Virginia under Captain Long for the space of three years. That he served out his time and was honorably discharged at Fort Sullivan by General Sullivan that he is now seventy years of age and has ever since been a Citizen of the U.S. that he now resides in Jessamine County Kentucky, that he is poor and by his reduced circumstances & old age stands in need of the assistance from his Country for support and begs to be inscribed on the Pension list as a Soldier of the Revolution and that he has received neither Pension [sic]. Given under my hand at Lexington this 1<sup>st</sup> day of April 1818 S/ Benj. Johnson, Circuit Judge

State of Kentucky Jessamine County Sct.

This day Robert Green<sup>1</sup> made oath before me a Justice of the peace for said County, that he was a Soldier of the Revolutionary War, that he served with William Lloyd and well knows he served the time stated in his affidavit here annexed and further states that he believes all the facts set forth in said affidavit of William Lloyd are true. Given under my hand this first day of April 1818

District of Kentucky Sct. Franklin County

On this 29<sup>th</sup> day of March 1821 personally appeared in open Court being a Court of record for the said district (established a Court of Record by an act of the Legislature of Kentucky and has the power to fine and imprisonment) and circuit of Franklin County, William Lloyd aged 72 years resident in Franklin County in said district who being first duly sworn according to law doth on his oath declare that he served in the Revolutionary war as follows "That he enlisted in Culpeper County in the State of Virginia for three years in Captain Gabriel Long's Company in Colonel Daniel Morgan's Rifle Regiment. That he served out his three years in said Regiment was honorably discharged at Fort Sullivan on the Susquehanna River in the

State of Pennsylvania or New York. That his original declaration is dated the first of April 1818 and the number of his pension certificate is 228.

And I do solemnly swear that I was a resident Citizen of the United States on the 18<sup>th</sup> day of March 1818 and that I have not since that time by gift, sale or in any manner whatever disposed of my property or any part thereof with intent thereby so to diminish it as to bring myself within the provision of an act of Congress entitled "an act to provide for certain persons engaged in the land and naval service of the United States in the revolutionary war" passed on the 18<sup>th</sup> day of March 1818, and that I have not nor has any person in trust for me any property, or securities, contracts or debts due to me nor have I any income other than what is contained in the schedule hereto annexed and by me subscribed

"One horse, bridle and saddle

That he is by trade a Taylor [tailor] that in the Army he got the palsy and his hand shaped so that he could not follow his trade, that his family consist of an old wife about sixty-nine years of age and that they live with one of their sons who supports him and his wife.

Kentucky Cumberland County Sct.

This day personally came before me the undersigned a Justice of the peace in & for said County William Lloyd of said County aged eighty three years this month who made oath that he enlisted into the service of the United States in the revolutionary war against Great Britain on the [blank] day of [blank] year 1776 in the County of Culpepper & state of Virginia for three years as a Seargant under Captain Gabriel Long [VAS970], that he continued to serve out his said Term of three years and received his discharge from Benj'n Asby Lieutenant [possibly Benjamin Ashby BLWt55-200] on the Susquehannah River state of New York [sic]. That he was at the Battles of Trenton [26 Dec 1776] & Burgoins defeat [defeat of Burgoyne at Freeman's Farm 19 Sep 1777 and/or Bemis Heights 7 Oct 1777] and Whitemarsh in Jersey [sic: Whitemarsh PA 5-8 Dec 1777] & there lost Major Harrison and other small skirmishes. That he has not received any land for his said service, that he served principally under Capt Morgan – he was also at the battle of Monmouth [28 Jun 1778].
