I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." On this 23rd day of October 1822 personally appeared in Open Court being a Court of record for the said State, and Circuit of Estill James McCristy age 62 years resident in Estill County and State aforesaid, who being first duly sworn according to law doth on his oath declare that he served in the Revolutionary War as followeth: – he enlisted for 18 months in the year 1780 near the Monongahela 40 miles above Pittsburgh in the State of Virginia in the company commanded by Captain Uriah Springer in Colonel John Gibson's Regiment in the Virginia line on Continental establishment. That he continued to serve in said Corps principally Stationed at Pittsburgh until the month of October 1781, when he was home two Campaigns against the Indians from Pittsburgh and was in two small engagements against the Indians during said term of service; That he continued to serve out the time for which he enlisted as aforesaid and was discharged from said Service at the expiration of said 18 months at Pittsburgh but has lost or mislaid said discharge, so that he cannot now produce it to corroborate the above statement, That he has no other evidence of his services than the affidavits hereto attached.

And I do solemnly swear that I was a resident Citizen of the United States on the 18th day of March 1818 and that I have not since that time by gift, sale or in any manner whatever disposed of my property or any part thereof with intent thereby so to diminish it as to bring myself within the provision of an act of Congress entitled "an act to provide for certain persons engaged in the land and naval service of the United States in the revolutionary war" passed on the 18th day of March 1818, and that I have not nor has any person in trust for me any property, or securities, contracts or debts due to me nor have I any income other than what is contained in the schedule hereto annexed and by me subscribed

I am a farmer by occupation but cultivate rented land, my family consist of 7 children (my wife being dead) – Polly aged 26 years, John 24 years, William aged 22 years – Sallie about 18 years, Jesse about 15 years, Isaac 12 years and James about 7 years. That all of said children except James are able to support themselves by their own labor, he states that he is very infirm and not able to support himself without the assistance of his country, that none of his said children now live with him except Sallie, Jesse, Isaac and James. Before me the undersigned Justice of the peace within and for the County aforesaid personally came William McChristy of Preble County in the State aforesaid who being of lawful age and sworn according to law deposeth and saith that he is the brother of James McChristy of Estill County Kentucky and some time before the close of the War of the American Revolution this deponent and the said James lived with their father on territory that was then in dispute between the States of Pennsylvania and Virginia and which afterwards made part of Westmoreland or Fayette County Pennsylvania. The said James was probably about the age of twenty-one years and this deponent then understood from said James and others that he the said James had enlisted in the Continental Army for the term of 18 months and this deponent recollects very well that the said James McChristy left his father's house and started to join the Army at Fort Pitt, now Pittsburgh and that he was absent long enough to have served said tour of 18 months except only that he came home to his father's twice during said term One time on furlough and the other time with two other Soldiers who were said to be sergeants in pursuit of deserters.
