Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

## Georgia Screven County: in the Superior Court

Personally came Timothy McKinney and being sworn saith that on or about the twentieth day of July in the year 1775 he enlisted in the service of the United States as a private soldier in the revolutionary war in Capt. John Colwells [sic, John Caldwell's] Company and third Regiment commanded by Col. William Thompson [William Thomson] for the term of three years during which time he was taken prisoner on the St. Tilla River [sic, Satilla River] and Fort McIntosh by the British and Indians and from the time he enlisted he continued in the service of the United States during the said War, and further saith he is a native born citizen of America, and enlisted in the State of South Carolina, and now lives in the State and County above mentioned, and further states that he has never been placed on the pension list; and that he was discharged at Charlestown by Lt. Col. James Mason [sic, James Mayson?] on the twentieth day of July in the year 1778, which discharge has from the many changes of life and lapse of time has been lost and is not in the power of this deponent, and further saith he is old and infirm and in capable now to support himself, and stands in need of the provisions made by the Congress of the United States for old and infirm soldiers for that he is now nearly blind therefore in a very helpless situation.

William Thompson's Regiment and that he knows that he Timothy McKinney served more than nine months successively -- that he was a faithful soldier as he believes.

I Timothy McKinney do solemnly swear that I was a resident Citizen of the United States on the 18<sup>th</sup> day of March 1818 and that I have not since that time by gift, sale or in any manner whatever disposed of my property or any part thereof with intent thereby so to diminish it as to bring myself within the provision of an act of Congress entitled "an act to provide for certain persons engaged in the land and naval service of the United States in the revolutionary war" passed on the 18<sup>th</sup> day of March 1818, and that I have not nor has any person in trust for me any property, or securities, contracts or debts due to me nor have I any income other than what is contained in the schedule hereto annexed and by me subscribed Sworn to before me this 9th day of November 1820
