Pension application of Darby McGannon S36104 Transcribed by Will Graves

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call errors or omissions to my attention.]

State of Kentucky [Gallatin] Galatin County Sct.

On this 27th day of August 1818 before me the Subscriber one of the Judges of the Circuit Courts for the State aforesaid assigned for the circuit aforesaid personally appeared Darby Macgannon aged sixty-two years resident in the County of Gallatin in the said district who being by me first duly sworn according to law doth on his oath state in order to obtain the pension made by the late act of "Congress entitled an "an act to provide for certain persons engaged in the land & naval Service of the United States in the revolutionary War" that he the said Darby Macgannon was enlisted in County of Culpeper in the State of Virginia on the 3rd day of April 1777 by Captain Moore Fontleroy [Moore Fauntleroy] who then commanded the third troop of the fourth Regiment Light dragoons commanded by Colonel Stephen Moyland [Stephen Moylan] that he served the term of three years when he was discharged in the month of March 1780 at Middletown in the State of Connecticut by the Colonel commanding said Regiment, which said discharge has been lost by time and accident that he is now laboring under the infirmity of old age & in needy circumstances with a large family to support & stands in need of the assistance of his country for support that he has not any further evidences of his services within his power.

On this 28th day of March 1825 personally appeared in open court it being a court of record (to wit) the Circuit Court of Jennings County Darby McGannon aged sixty-nine years who being first duly sworn according to law doth on his oath make the following Declaration in order to obtain the provisions made by the acts of Congress of the 18th of March 1818 and 1st of May 1820 that he the said Darby McGannon enlisted for the term of three years in April 1777 in the State of Virginia in the company commanded by Captain Moore Fontleroy [Moore Fauntleroy] in the Regiment commanded by Colonel Stephen Mayland [Stephen Moylan] in the line of the State of Virginia on the Continental Establishment and that he continued to serve in said Corps until March 1780 when he was Discharge from said service in the Town of Middletown in the State of Connecticut and that he was in the Battles of Monmouth [June 28, 1778] and at Philadelphia and Brandywine [September 11, 1777] and that he has no other

evidences of his service. And in pursuance of the act of the first of May 1820,

I do solemnly swear that I was a resident Citizen of the United States on the 18th day of March 1818 and that I have not since that time by gift, sale or in any manner whatever disposed of my property or any part thereof with intent thereby so to diminish it as to bring myself within the provision of an act of Congress entitled "an act to provide for certain persons engaged in the land and naval service of the United States in the revolutionary war" passed on the 18th day of March 1818, and that I have not nor has any person in trust for me any property, or securities, contracts or debts due to me nor have I any income other than what is contained in the schedule hereto annexed and by me subscribed

I have one half Quarter Section of very poor land Two indifferent horses Three head of cattle, 1 Sheep & 3 hogs I have a wife and five children two boys Alexander nineteen years old Hugh twelve years old my Daughters Jane is eighteen years old Salley and Aylesey twins are fifteen years old. I am a Farmer by trade and not able to work at all by Reason of old age and Infirmity.

Sworn and subscribed to before the Honorable Circuit Court of Jennings County this 28th of March 1825

State of Indiana Jennings County: In Obedience to an act for the Relief of certain officers & Soldiers of the Army of the Revolution approved on the 15th of May 1828, I Darby McGannon of the County of Jennings & State of Indiana do hereby declare that I enlisted in the Continental line of the Army of the Revolution for the term of 3 years and continued in that Term, at which Period I was (Corporal) in Captain Moore Fauntleroy's Maryland Regiment 4th. That he enlisted in Virginia & discharged in Middle Town Connecticut – that he has heretofore received a pension from the United States heretofore.

I also Declare that I have received a Certificate for my proportion of Services as other Soldiers did & I further declare that I was put on the 18th of March 1828 on the pension List of the United States.
