Pension application of Thomas Melton (Milton) S36116 Transcribed by Will Graves

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call errors or omissions to my attention.]

District of Kentucky SS

On this 23rd day of September 1819 before me the subscriber, Judge of the Fayette Circuit Court for the State of Kentucky, personally appeared Thomas Melton aged about Sixty-eight years, resident in Shelby County of said State, who being by me first duly sworn according to law doth on his oath make the following declaration in order to obtain the provision made by the late act of Congress entitled "An act to provide for certain persons engaged in the land and naval service of the United States in the revolutionary war:" That he the said Thomas Melton enlisted for the term of 3 years or during the war on the ___ of ___ 1777 in the County of Louden [Loudoun] in the State of Virginia in the company commanded by Captain Marquis Calmes of the 2nd Regiment commanded by Colonel Alexander Spotswood in the line of the State of Virginia aforesaid on the Continental establishment, that he continued to serve in the said Corps or in the Service of the United States until the 12th of May when he was taken at the siege of Charleston by the British with whom he was detained about 16 months at which time he made his escape, that soon after his return he was discharged from service by General Morgan at Winchester in the State of Virginia: that he was in the Battles of Monmouth [June 28, 1778]. Taking of Stony Point [July 16, 1779] &c and that he is in reduced circumstances and stands in need of the assistance of his country for support, and that he has no other evidence now in his power of his said Services (except as is annexed).

The said Melton further states, that sometime in the month of June 1818 – he made out his declaration as he was informed and believed, conformably to the requisitions of the Act of Congress above referred to, that he had it forwarded to the war office and that he has lately been informed by letter from John L Edwards Esquire Clerk of the Pension office addressed to Colonel James Morrison of Lexington Kentucky that there was some defect in said declaration & that it had been handed to the Honorable H. Clay [Henry Clay] of Congress for the purpose of having it amended: that he is informed application has been made to Mr. Clay for it, who says that if he received the paper referred to he does not remember it and can't now find it.

I do hereby Certify that Thomas Melton was enlisted by my instruction in the County of Loudoun in the State of Virginia in the year 1777 as a Soldier for the 2^{nd} Virginia Regiment which Regiment I commanded a company in – and to the best of my memory the said Melton enlisted for three years or during the war in the aforesaid Company & Regiment and that in the year 1779 I resigned and to the best of my recollection I left the aforesaid Melton in the aforesaid

Company and Regiment which was then commanded by Colonel Alexander Spotswood Since General Alexander Spotswood of Virginia –

Fayette County to wit September Court 1820

On motion of Thomas Melton who produced in open Court his pension Schedule and certificate which was sworn to It is ordered that the same be recorded and certified to the Secretary of the war Department which is in the following words to wit:

District of Kentucky SS

Fayette County Court

On this 12th day of September 1820 personally appeared in open Court, being a Court of record for the said District, and Fayette County, having by act of Assembly its proceedings recorded and possessing power to fine and in prison for content, Thomas Melton aged seventy years, resident in Clark County in said District, who being first duly sworn; according to law, doth on his oath declare that he served in the Revolutionary war as follows; He enlisted for 3 years or during the war in 1777 in Loudoun County Virginia under Captain Marquis Calmes of the second Regiment on Continental establishment commanded by Colonel A. Spotswood, served till taken at the siege of Charlestown [Charlestown South Carolina May 12, 1780] by the British, was a prisoner about 16 months, escaped and then discharged by General Morgan in Winchester Virginia. He was in the battles of Monmouth, taking of Stony Point, &c and I do solemnly swear that I was a resident Citizen of the United States on the 18th day of March 1818 and that I have not since that time by gift, sale or in any manner whatever disposed of my property or any part thereof with intent thereby so to diminish it as to bring myself within the provision of an act of Congress entitled "an act to provide for certain persons engaged in the land and naval service of the United States in the revolutionary war" passed on the 18th day of March 1818, and that I have not nor has any person in trust for me any property, or securities, contracts or debts due to me nor have I any income other than what is contained in the schedule hereto annexed and by me subscribed.

Has no property except his closed and very few of them, -

Has no debts due him and owes about \$1.50.

My occupation was farming, when I was able to work, I can now do nothing, my wife aged about sixty years and myself are living with our children, sometimes one and then another.

Thomas Melton appeared before me a Justice of the peace for said County and made oath that in the year 1777 in Loudoun County Virginia he enlisted for 3 years in the company commanded by Captain Marquis Calmes in the 2nd Virginia Regiment on Continental line commanded by Colonel Alexander Spotswood and that he continued to serve in the said Regiment until the month of May in the year 1781 at which time he was honorably discharged from service by General Morgan making a service of nearly 5 years and that through the course of time he has lost his Discharge and that he has never received his land Warrant for said Service.

State of Kentucky Woodford County Sct.

Marquis Calmes appeared before me a justice of the peace for said County and made oath that he was a Captain in the 2nd Virginia Regiment on Continental establishment in the year 1776 and in the year 1777 I enlisted the aforesaid Thomas Melton as a soldier for the 2nd Virginia Regiment for 3 years or during the war, and as well as my memory serves me, I left said Melton in the service in the month of March 1779, when this deponent left Army as a Captain, and that he has understood, and believes that said Melton served out the term of 3 years or the time for which he enlisted.
