Pension application of John Payne S3627 Transcribed by Will Graves f18VA rev'd 9/26/12

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." State of Tennessee, Sumner County

On the 21st day of August 1832 personally appeared in open court before the Justice of the County Court of Sumner now in setting, John Payne, a resident in the county and state aforesaid, aged seventy seven years, who being first duly sworn according to the law, doth on his oath make the following declaration, in order to obtain benefit of the Act of Congress passed the 7th of June 1832. That he enlisted in Bedford County, Virginia for two years on the 9th of February 1776 under Capt. Gross Scrugs [Gross Scrugs], was attached to the 5th Regiment of the Virginia Line, commanded by Col. Stevens or Stevenson [probably Edward Stevens], marched to Portsmouth, in Virginia, and remained there and in its vicinity until the 11th day of August when applicant, who had been in such bad health that he had been incapable of performing duty, was discharged by Capt. Scruggs by permission of Col. Stevens upon Furlough until he should recover and be able to perform duty, when he was again to return to his company. Applicant continued unable to do duty for a long [time] after the two years expired. After Capt. Scruggs had served out his term of two years and returned home, he gave applicant a full and complete discharge. Applicant will here state all of his officers: Col. Stevens or Stevenson, Major Isaiah Parker & Major __ Parker, Capt. Gross Scruggs, 1st Lt. Isham Talbot, 2nd Lt. Joseph Arly & Ensign Barney Arthur. The 4th Regiment of the Virginia Line was stationed also at Portsmouth the officers not now recollected, except Capts. Brunt & Morton. Applicant has either lost or mislaid his furlough and discharge; he has no documentary evidence of his service, nor does he know of any person living whose testimony he can procure by whom he can prove his service.

He hereby relinquishes every claim whatsoever to a pension or an annuity except the present, and he declares that his name is not on the Pension Roll of any Agency in any State. Sworn to and subscribed the day and year aforesaid in open court.
