Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." On this thirteenth day of May 1819, before me, one of the Probate Judges of Davies Circuit Court for the said District, personally appeared Job Hammond aged Seventy Nine years on the first day of June 1819; resident in the State aforesaid, who being by me first Sworn, according to law, doth on his oath, make the following declaration, in order to obtain the provision made by the late act of Congress, entitled "An Act to provide for certain persons engaged in the land and naval Service of the United States in the revolutionary war": that he the said Joe Hammond entered the service in the Militia of South Carolina on or about the 30<sup>th</sup> day of November in the year 1775 in company Commanded by Captain Thomas Brandon, of the Regiment commanded by Colonel John Thomas of South Carolina militia, having served under the following Captains until just before the battle of Cowpens [January 17, 1781] Captain Joseph Jolly – Joshua Palmore [sic, Joshua Palmer] and Benjamin Jolly, when he the said Job Hammond enlisted under Benjamin Jolly, in the Horse or dragoons for Colonel Washington's [William Washington's] Regiment, with whom the said Joe Hammond continued until the end of the War; when having received a furlough he returned home, consequently did not receive a discharge – he the said Job Hammond was in the following battles against the Tories – at the Cain brake [Great Cane Brake, December 22, 1775] – with General Williamson [Andrew Williamson against the Indians between the valleys and the middle Settlements-- Siege of buck head -- Orangeburg - Congarees - Cowpens - Siege of 96 [May 22-June 19, 1781] - that he is now in reduced circumstances, and stands in need of the assistance of his Country for Support; and that he has no other evidence in his power.

On this 23<sup>rd</sup> September 1819 before me, one of the Associate Judges of Davies Circuit Court, for the said district personally appeared Job Hammond who deposeth and Saith that the first Regiment he served and was the 13<sup>th</sup> Regiment of South Carolina commanded by Colonel John Thomas – after which he enlisted in Colonel Washington's Regiment but does not recollect what line it was, and furthermore he sayeth not. At the Circuit Court in and for the first Judicial circuit of the State of Indiana held in and for the County of Davies: Being a Court of Record: as it is one of the Circuit Courts of the State aforesaid: on this third day of December A.D. 1821 personally appeared in said Court of record Job Hammond aged Eighty years: resident in said first Circuit and in said County of babies who being first duly Sworn according to Law doth on his oath declare that he Served in the Revolutionary war agreeable to the papers sent on to the war department by virtue of which he has received a pension:

And I do solemnly swear that I was a resident Citizen of the United States on the 18<sup>th</sup> of March 1818 and that I have not since that time by gift, sale or in any manner disposed of my property or any part thereof with intent thereby so to diminish it as to bring myself within the provisions of An Act of Congress entitled "An Act to provide for certain persons engaged in the land and naval Service of the United States in the Revolutionary War," passed on the 18<sup>th</sup> day of March 1818; and that I have not, nor has any person in trust for me, any property or securities, contracts or debts due to me, nor have I any income other than what is contained in the Schedule hereto annexed and by me Subscribed:
